If you have a printer at home, visit the ELW website at ELW-FL.com, click on ELWCA Community Association, then Controlled Access. There are three (3) files that you will need to read and complete as follows:

- 1. Controlled Access Waiver Controlled Access (read)
- 2. Barcode Placement (read)
- 3. Controlled Access Registration Form (complete)

If you do not have a printer at home, the above documents can be obtained at the management office, or you may email a request to have the documents sent to you at rdavis@mgmt-assoc.com.

Should you elect to obtain your barcode in person at our office, please be advised that the following rules are in effect:

- Please complete all paperwork prior to arriving at the office
- barcodes will be issued Monday through Thursday between 8:00AM and 11:45AM and from 1:00PM to 4:00PM.
- No PETS or unsupervised children will be permitted in the office.
- No food, drinks, or smoking will be permitted in the office.
- No vulgar language, yelling or any type of verbal or physical abuse will be tolerated.

ELW Owners:

<u>Proof of residency:</u> Either a driver's license reflecting Eastlake Woodlands address, warranty deed or closing statement reflecting a recent purchase and a copy of the vehicle registration.

<u>Vehicle Registration</u> for each vehicle a barcode is being assigned. One barcode will be issued per vehicle.

Renters:

<u>Proof of Rental:</u> Renters must provide a copy of the lease. Barcodes will NOT be issued to renters with a lease term of less than 3 months.

<u>Vehicle Registration</u> for each vehicle a barcode is being assigned. One barcode will be issued per vehicle.

Owners with New Vehicles: If you sell/trade in your vehicle, you will be required to purchase a new barcode for the new vehicle. A copy of the registration will need to be provided as well.
