Social Engineering Types

- Phishing
 - Scams impersonating legitimate sources to steal data.
- 2 Spear Phishing

Targeted phishing attacks tailored to a specific individual or organization.

3 Smishing

Phishing attacks conducted via SMS/text messages.

- Luring victims with false promises (e.g., free downloads) to steal data.
- Vishing

 Phishing attacks using voice calls (e.g., fake tech support or bank calls).

Malicious Attachments

Malicious email attachments can retrieve your personal information and your password.

Always double-check the link before clicking!

Synthetic Identity

Al-Enhanced Phishing

Automated Attacks

Fake videos, voices, or images to impersonate trusted individuals.

Deepfake Fraud

Combines real and fake data to create convincing fake identities.

More personalized and convincing scams using Algenerated content.

Al tools scale social engineering attacks (e.g., mass spear phishing).





- Public Wi-Fi Caution
- Use VPN

- Manage Cookies

- Limit Online Sharing
- Social Media Caution
- Validated Downloads

Setting Passwords: Rules to Follow

- Minimum length of 8 characters
- Unique for each system
- A complex password

- Audit your accounts
- No word in the dictionary
- Use a password manager

Third-party Data Sharing Principles



Retention Period

Store data only as long as needed



Transparency

Inform individuals when sharing data



Data Minimization

Share only necessary data, avoiding excess



Legal Basis

Share data with consent/obligation/contract



Data Processing Agreement

Set clear responsibilities for data protection



Data Security

Ensure security measures to prevent breaches

Protection of Personal Data (Singapore)



PDPA in Singapore

It sets standard for personal data protection and comprises requirements governing the collection, use, disclosure and care of personal data.



Scope of PDPA

The law covers electronic and nonelectronic personal data but exempts personal/domestic activities, employee data, public agencies, and business contact information.



Objectives of PDPA

It safeguards personal data from misuse and mandates compliance for data collection, use, and disclosure.



Protection of Personal Data (Hong Kong)



PDPO in Hong Kong

It regulates both private and public sectors under technology-neutral principles, ensuring minimal and secure data collection while granting individuals access and correction rights.




Key Definitions

The PDPO defines personal data as identifiable information about living individuals, Data Users as controlling collection/processing and Data Processors as handling data under contractual obligations.



Criminal Liability

Violations like unauthorized direct marketing face fines up to HKD 500K and 3-year imprisonment, while unlawful data disclosure incurs HKD 1M fines and 5-year imprisonment.
