Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

While our fees are considered reasonable and competitive, we at Felipe Bagues Mortuary distinguish ourselves through the quality of our service, superior facilities and a willing attitude to fulfill the needs and wishes of every client. Basic Services of Funeral Director and Staff \$2300.00

Our fee for the services of Funeral Director and Staff includes, but is not limited to: Staff to respond to the initial request for service; arrangement conference with family and responsible party; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics, shelter of remains; and staff assistance prior to, during and following the funeral including coordination with those providing other portions of the funeral, (e.g. cemetery, crematory and others). The Funeral Home has also incorporated into the above charge's overhead expenses such as professional licensing, legal and accounting fees and OSHA and environmental compliance, insurance, building and utility expenses, parking lot and grounds, maintenance, taxes, equipment, furnishings, inventory costs, record keeping, and secretarial administrative expenses. This fee for our basic and overhead will be added to the total cost of the funeral arrangement you select. (A basic fee is already included in our charge for direct cremations, immediate burial, and forwarding and receiving remains) As an optional discount, if a casket is purchased from our funeral home (and utilized) as part of this service, please deduct \$1000.00 from our SERVICES OF FUNERAL DIRECTORS AND STAFF. Please note there is an additional \$425.00 fee for a Saturday service.

Embalming \$525.00

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you pay for it, such as direct cremation or immediate burial. (Refrigeration, if applicable, \$50.00 per day. California law requires refrigeration of an un-embalmed body after 24 hours) Additional fee for embalming of tissue/bone donation remains: \$300.00

Other Preparation of the Body \$200.00

Other preparation includes dressing, casketing and necessary preparation when mortuary is only funeral home providing all funeral services. For ship-in cases, to remove the decedent from outside casket/container, dress and re-casket \$400.00)

Additional Preparation of the Body

Necessary care of un-embalmed remains (bathing, refrigeration. & feature setting) \$400.00.

Restorative art, additional cosmetology (per hour) \$150.00.

Autopsy repair (when required for Medical Examiner/Coroner's cases) \$200.00.

2nd or additional casketing (when necessary) \$200.00

Request for hair tinting (hair tint brought in by family) \$75.00. Disaster Pouch (when necessary for decomposed remains) \$200.00. Necessary care of remains in poor condition (channeling)\$200.00.

Request for appointment to assist in dressing, cosmetology, and/or hair of deceased \$200.00.

(2 persons' maximum, by appointment only. (if schedule permits)

ID of remains (Max 2 persons) \$200.00.

Transfer of Remains to the Funeral Home (within 25-mile radius) \$695.00

Removal of remains from hospital, residence, Medical Examiner/Coroner offices or any other facility. (Price subject to change if service is outside 25-mile radius from mortuary).

Use of Facilities and Staff for Viewing at the Funeral Home \$300.00

Our services will include the setup of services, use of Felipe Bagues Mortuary chapel and lounges, placement of encased remains or cremated remains, display of floral arrangements, and professional supervision during the visitation or funeral ceremony in our facility. Hours of use for our services are the following:

- Casketed Remains: 1 to 3 hours are included. Additional time is available at \$250 per hour (maximum of 2 extra hours, concluding no later than 9:00 PM).*
- Memorial Services (M-F): 1 to 2 hours are included, scheduled between 9:00 AM and 2:00 PM.*

Funeral Service or Ceremony at Other Facility \$150.00

Our services will include set up of visitation, professional supervision and attendance during funeral ceremony committal and other service and staff necessary to conduct funeral ceremony at other facility. Residence delivery includes, set up of visitation, casket trolley and limited supervision.

Hearse \$375.00

To transport casket/remains to place of service (Price subject to change if service is outside 25-mile radius from mortuary)

Utility Vehicle \$100.00

Vehicle used to obtain disposition permits at local health department and all other necessary documents needed for the burial or cremation. Vehicle is also used to transport flowers to cemetery when necessary. Flowers are picked up in the morning from location of evening service. Flowers are taken to the cemetery during morning service and will not be present at any next day ceremonial service. If vehicle is used to transport flowers to a second location, there will be an additional fee of \$200.00 applied. (Price subject to change if service is outside 25-mile radius from mortuary).

Utility Vehicle to Airport \$275.00

Use of vehicle for airport delivery and processing. (Price subject to change if service is outside 25-mile radius from mortuary).

Utility Vehicle to Crematory \$275.00

Use of vehicle to crematory and processing. (Price subject to change if service is outside 25-mile radius from mortuary).

Processing Amended Documents \$150.00

Includes basic services of funeral director and staff in amending death certificates and disposition permits.

Procurement of Apostille \$260.00

This includes procurement of necessary documents for an apostille on a death certificate (death certificate fee not included). This includes vehicle, staff, mileage, parking fees used to travel to Los Angeles County Registrar, Health department fees and the Secretary of State fees. (If death certificate is from another county other than Los Angeles there will be additional mileage charges up to \$4.50 each additional mile) Cost includes 1 apostilled document, each additional apostille is \$20.00. Notarized cremation letter not included if required.

Processing Insurance Documents 5% of contract total

Includes basic services of funeral director and staff in processing insurance documents for payment of the funeral contract. This does not include the cost of the certified death certificate if needed by the insurance company.

Alternative Selections – Special Packages

Forwarding of Remains to Another Funeral Home \$3,419.75

Includes basic services of funeral director and staff, a proportionate share of overhead costs; removal to mortuary, embalming or other preparation of remains, combo unit, transportation to airport, 1 certified death certificate, 1 disposition permit. Does not include airline fee or taxes.

Receiving Remains from Another Funeral Home \$3,362.00

Includes basic services of funeral director and staff, a proportionate share of overhead cost, temporary shelter of decedent, use of facilities and or equipment for service, disposition permit. Removal to mortuary not included.

Direct Burial \$4,238.98

A direct burial is disposition of human remains by burial, without dressing, formal viewing, visitation or ceremony with the body present. Embalming is not necessary. Our charge for this service includes, basic services of funeral director & staff, removal of decedent, facilities for shelter prior to burial, oval top casket, obtaining & filing necessary authorization & permits, 1 certified death certificate and local transportation.

Direct Cremation \$3,878.33

Package Savings \$1,302.85 TOTAL \$2,575.88

A direct cremation is disposition of human remains by cremation, without formal viewing, visitation or ceremony with the body present. Our charge for this service includes basic services of funeral director & staff, a proportionate share of overhead cost, removal of decedent, facilities for shelter prior to cremation, obtaining & filing necessary authorizations & permits, 1 death certificate, cremation container, local transportation to crematory, crematory fee and picking up of cremated remains from the crematory.

Viewing With Cremation Service \$4,728.00

Services include basic services of funeral director and staff, removal of remains, embalming and preparation of the body for viewing, rental casket, use of the chapel for viewing, transportation to crematory, crematory fee, 1 death certificate, disposition permit and return of cremated remains to legal next of kin.

Direct Cremation with Memorial Service \$4,178.73

Services include basic services of funeral director and staff, removal of remains, necessary authorizations, 1 death certificate, disposition permit, cremation container, transportation of remains to crematory, cremation fee, return of cremated remains to the mortuary, 2-hour memorial service between 9am- 2pm (select 2 hours at family convenience) Monday through Friday, use of facilities and staff for memorial services, and return of cremated remains to the legal next of kin.
