# DNC WINTER MEETING RECAP

Thank you again for allowing me to serve as your Representative on the DNC. Since we met last, we had the DNC National Convention in Chicago in August 2024. We celebrated the historic nomination of Vice

President Kamala Harris and Tim Watz as our nominees for President and Vice President for the Democratic Party. It was a great convention with many caucuses and council meetings and uplifting speeches at the nightly convention meetings. I was honored to Chair the Black Caucus meeting with over 3000 attendees at the convention. The convention ended on Friday with a DNC meeting to wrap up the convention and welcome DNC new members.

When we returned from the convention a bus tour was started in the Southern Region for the newly nominated Presidential/Vice President ticket.

The DNC Executive Meeting was held in Washington, DC on December 13, 2024. We heard several reports. Chair Harrison highlighted the many successes of the Biden Administration and the three pillars of work that the DNC had done since he took office in 2021. The Rules and By Laws Committee gave Rules for the election of upcoming officers for DNC. Each candidate was allowed to speak in the meeting.

The winter meeting was held on January 30-February 1, 2025, at the Maryland National Harbor Convention Center. A welcome was given by Governor Wes Moore and Maryland Democratic Party Chair Ken Ulman. We had the annual Black History Breakfast, and Committees and Caucus meetings. On Saturday, February 1st, reports were given and the rules were voted and accepted.

We had the elections of new officers. Ken Martin of Minnesota was elected as DNC Chair. Reyna Walters Morgan was elected as Vice Chair/Civic of Engagement and Voter Participation. Jason Rae was reelected as Secretary. Virginia McGregor was reelected as Treasurer. Chris Korge was elected as Finance Director. Other officers were Artie Blanco as Vice Chair, David Hogg as Vice Chair, and Malcolm Kenyatta as Vice Chair. Outgoing Chairman Harrison gave the gavel to the new Chairman who thanked everyone for attending and meeting was adjourned.

I've attended many virtual and webinars since we met last. Thanks again for allowing me to serve as your representative.

The next full DNC Meeting will be August 2025 in Minneapolis, Minnesota.



### PRESIDENT - LOVIE WEST (SOUTH)

Lovie West is a product of the Civil Rights Movement. She grew up in central Mississippi in a military family, witnessed the injustices that plagued people of color, and grew up under the influence of giants such as Fannie Lou Hamer, Georgia Clark, Hattie McClellan and many other Mississippi women of the movement.

Ms. West earned a Master of Business
Administration, engaged in doctoral work in
Organizational Leadership, and holds certification
in Mediation and Human Resources. Professionally,
she was responsible for seventeen hotels while
being employed by Marriott Hotels where she
gained invaluable human resources, marketing,
sales, budgeting, and business operations
experience.

Ms. West was the founding President of DeSoto County Federation of Democratic Women where she launched a leadership institute, installed four new clubs, developed a new club orientation program, developed a financial policy and procedures manual, raised funds, and many other accomplishments. Lovie West also served as President of the Mississippi Federation of Democratic Women in addition to holding other executive positions in the organization.

Her contributions to the community via other organizations is extensive. Ms. West has served in leadership in the Democratic Party, Urban League, National Association for the Advancement of Colored People (NAACP), Alpha Kappa Alpha Sorority, Inc., and the Kennedy Center for which she has earned numerous awards for her service.

Politically, Lovie West has worked on many federal and state campaigns including those of Jimmy Carter, Bill Clinton, Barack Obama, Joe Biden/Kamala Harris, Ann Richards, Dr. Randy Watkins and Mike Espy where her impact ranged from grass roots organizing to managing entire campaigns.

Finally, Lovie West previously served as the 4th Vice President of the National Federation of Democratic Women and the co-chair of the Political Education Committee. She has attended three NFDW Conventions, three NFDW Women in Blue meetings, and many regional meetings. She is proud to have been elected as the NFDW President.



As President, Lovie West serves as board advisor for the following Committees: Administration, Bylaws, Convention Credentials, Convention Planning and Oversight, Convention Rules, Courtesy, History, Legislative, Platform, and Strategic Planning. President West also serves as Convention General on the Convention Leaders Committee.







### 1ST VICE PRESIDENT - CHRISTINE PELOSI (WEST)

Christine Pelosi of California is a nationally recognized Democratic strategist, attorney, and grassroots organizer with a lifelong commitment to public service and progressive leadership.

She has been a National Federation of Democratic Women (NFDW) member for two decades and has attended over a dozen NFDW Conventions. She previously served as the 3rd Vice Chair of the NFDW and Chair of Women in Blue, where she worked to elevate the voices of Democratic women, strengthen state and local chapters, and mentor the next generation of women leaders. She is Vice Chair for Campaigns and Elections at the Democratic National Committee (DNC), where she plays a central role in shaping strategy, supporting candidates, and expanding the Democratic base.

An author and educator, Christine wrote Campaign Boot Camp and Campaign Boot Camp 2.0, both of which have become essential tools for training candidates, advocates, and campaign staff. She has led boot camps and workshops across the country, with a special emphasis on preparing women, young people, veterans, and working-class organizers to run for office and lead effectively.

Her government service includes roles as Special Counsel at the U.S. Department of Housing and Urban Development during the Clinton administration, and as Chief of Staff to U.S. Representative John Tierney. In California, she has served as Executive Director, Platform Chair, and Women's Caucus Chair for the California Democratic Party, demonstrating a long-standing dedication to party building and inclusive leadership.

Christine Pelosi's career has been defined by her dedication to empowering others — especially women — to lead boldly and with purpose. Through her work with the Federation, the DNC, and her campaign training programs, she continues to be a driving force in shaping the future of the Democratic Party. She is excited for the next 2 years as your 1st NFDW VP.

### 2ND VICE PRESIDENT - INEZ JAMES (MIDWEST)

Inez James is the daughter of the late Frank James Jr. and Mary Elizabeth (Banks). A dynamic, people-focused leader, Inez is currently serving her fourth term as President of the Lorain Club of The National Association of Negro Business and Professional Women's Clubs, Inc. With 29 years of supervisory experience at the Ohio Turnpike and Infrastructure Commission, she brings seasoned leadership, accountability, and service to every space she enters.

Deeply engaged in civic and political life, Inez is a proud member of Delta Sigma Theta Sorority, Inc., Lorain County Alumnae Chapter, and serves as President of the Lorain County Democratic Women's Club. She is the elected Precinct Committee Person for Elyria Ward 7E and serves on the Ohio Association of Election Officials Legislative Committee. In 2021, Inez made history as the first African American and first woman appointed by Ohio Secretary of State Frank LaRose to represent the Democratic Party on the Lorain County Board of Elections–a role in which she continues to serve.



Inez also serves as Treasurer and Board Member of the Harrison Cultural Community Centre and is an active member of the Lori-El Unit of Parliamentarians.

She is widely recognized in Lorain County for her engaging portrayals of historical icons such as Sojourner Truth, Harriet Tubman, and Mary McLeod Bethune-bringing history to life through education and storytelling.

A passionate advocate for voter education and civic engagement, Inez uses platforms like WNZN 89.1 FM and WSAV-LP 93.7 FM to inform, inspire, and mobilize communities-especially those historically underserved. She is a life member of the NAACP (Metro-Central Unit) and a dedicated Democratic campaign strategist, having supported numerous candidates through media outreach, phone banking, canvassing, and community presentations.

Her personal motto, "Vote to allow your voice the power to make a difference for your community, your family, and our future," guides her tireless work to ensure that every citizen is empowered to participate fully in our democracy.

In addition to her civic leadership, Inez is an ordained minister and a devoted member of Living Word Church in Lorain, Ohio, where she serves under the spiritual guidance of Reverend Ray H. Robinson Jr. and First Lady Holly Robinson.

She is delighted to serve as your 2nd Vice President.

### 3RD VICE PRESIDENT - JOYCE PETTEWAY (EAST)

Joyce Petteway currently serves as the President of the Connecticut Federation of Democratic Women (CFDW) and over the past few years has become increasing involved at the national level as well. Joyce has attended the past number of annual NFDW conventions, including in person conventions in Louisiana (2023) and Ohio (2024) and the previous Virtual Conventions in 2021 and 2022. She also was a delegate to the Democratic National Convention in Chicago in 2024, always returning to CFDW with a wealth of information to share with her members.

Joyce has been an active member of the Greater Hartford Progressive Democratic Women's Club, served as its' President and the State Federation for many years. She was a delegate to the Democratic National Convention in 2012 and 2024.

She is a past president of the Waterbury Chapter of the National Congress of Black Women, a former State President of the Sojourner Network of Democratic Women, the Waterbury NAACP Education Chairwoman, and as a Board Member of the Connecticut Community Foundation. Joyce also serves as an Assistant Moderator for local elections. Ms. Petteway was the Founder of the Women's Political Institute in Connecticut and served as a facilitator for several Leadership and Community Engagement Forums in her hometown of Waterbury, CT.

As 3rd Vice President, Joyce Petteway serves as board advisor for the following Committees: Public Relations and Communications including Social Media, Marketing, Website and Technology. Ms. Petteway retired from the Office of State
Treasurer Denise Nappier where she served in the
position of Investment Technician in the Debt
Management Division. Her dedication and work ethic
has spread to her community as well, where she
served as a board member of her local Neighborhood
Housing Services, Alderwomen and President Pro
Tempore of the Waterbury Board of Education and
currently serves as a Trustee and Office Manager of
Grace Baptist Church in Waterbury.

She has been at the forefront of change for more than 20 years. Serving in various leadership roles has made her realize that the struggle continues not only for women, but for everyone who does not have a voice. She has devoted her career to serving others in her community and for the Democratic Party.

She is a dedicated Federation member, actively involved, and passionate about increasing membership and working towards electing Democrats at all levels. She has been a tireless, dedicated public servant for many years and looks forward to serving as your 3rd Vice President.





### 4TH VICE PRESIDENT - TELISE EZELL TURNER (SOUTH)

Retired Lieutenant Colonel Telise Ezell-Turner is a retired United States Army Nurse. Retired Lt. Col Ezell-Turner joined the United States Army to assist in the Vietnam War and became a commissioned officer in the U.S. Army Nurse Core, serving twenty-two years honorably. Retired Lt. Col. Ezell-Turner was professionally trained as a Registered Nurse (RN), earning a master's degree in nursing (MSN) with a concentration in nurse administration.

Retired Lt. Col. Ezell-Turner has served as President of the Tennessee Federation of Democratic Women. She has also held the role of Vice President of the organization in addition to serving in other significant committee roles. Retired Lt. Col. Ezell-Turner has also been an active member of the Democratic Women of Shelby County and served the community through her work on the Rotary Club of Memphis Central Foundation Board, where she was the first African American women elected to the organization. During her tenure at the Rotary Club, Retired Lt. Col Ezell-Turner has served as

President and fundraising lead, overseeing a budget of over \$500,000 to support a variety of service projects annually.

She is also a member of the Tennessee Beta Unit of the National Association of Parliamentarians, a member of Zeta Phi Beta Sorority, Inc., currently vice president of Frayser Community Development Corporation Board, and contributes to numerous other community and professional organizations. Retired Lt. Col Ezell-Turner has been given many awards including a proclamation from Shelby County Government for her work in improving the lives of women and children in Shelby County.

Finally, Retired Lt. Col Ezell-Turner has also served the National Federation of Democratic Women through her work on the 2022 nominating committee and NFDW Awards Committees. She has attended six NFDW national conventions and six regional meetings.

She is honored to serve as your 4th Vice President during the next two years.

### 5TH VICE PRESIDENT - IRMGARD PAGAN (EAST)

Irmgard Pagan (Eastern Region) has been a loyal and dedicated member of NFDW for several years. She has been president of the Puerto Rican Chapter of NFDW, which is considered a full member state by the rules and bylaws of NFDW for several years. Irmgard successfully organized and chaired two successful NFDW conventions, in 1996 and again in 2009. She is fully bilingual, speaking English, Spanish, and French fluently.

Irmgard served as the Eastern Regional Director of NFDW for the past two years and was successful in getting the State of Maine to become federated and join the NFDW. She has also served on various NFDW committees during her extensive years as a member of NFDW. She was a delegate to the Democratic National Convention in 2008 and 2012.

Irmgard is an accomplished attorney and has worked closely with the Governor of Puerto Rico, the Senate and House of Puerto Rico, 18 government agencies and 35 municipalities. She has served as the legal advisor to the President of the Senate of Puerto Rico, legal advisor to the President of the House of Representatives of Puerto Rico, Director of the Legal

Division of the Puerto Rico Planning Board, and as a Hearing Examiner for the Puerto Rico Labor Relations Board.

Ms. Pagan holds a Master's Degree in International Law from New York University, a Juris Doctor Degree of the Interamerican University of Puerto Rico Law School in San Juan, Puerto Rico and has offices in Puerto Rico and the Washington, DC area. She has a Bachelor's Degree in political science and Drama from the University of Puerto Rico.

In her spare time, Ms. Pagan has co-authored 2 books and has been a Hollywood producer, producing thrillers about the corruption of the legal system, the war on terrorism, and the corruption of the movie business in Hollywood.

Her experience and knowledge of local politics and international law politics make her an ideal candidate for this position. She has focused on the fight for women's rights and the well-being of all Americans and has been a leader in promoting Statehood for Puerto Rico for many years. 

I was truly honored to lead the NFDW Bylaws Committee and contribute to the important work of our organization.

The Committee met on April 8, 2025 at 5:00pm Central Time via Zoom. Present at the meeting were Kim Savage, Joanne Sullivan, Joyce Petteway and Kathy Adams.

A request for a Bylaws Change to Article IX, Section 3 Decorum was submitted by Celeste Garcia and the DC Federation of Democratic Women.

Article IX, Section 3 was discussed. The requested amendment added more specific language regarding proper decorum at NFDW meetings and functions.

- The Committee members present amended the language that was submitted and agreed that THE CHANGE IS RECOMMENDED BY THE COMMITTEE.
- Summary of the current and proposed language with rationale is in the following pages.

The Committee also discussed Article III, Section 5 Individual Membership:

- When a person from a full member state pays NFDW directly for individual membership, they are
  informed that they are members of a state federation, but the state receives no benefit from the
  membership. Committee members amended the language to require that dues for state federations
  be credited to reflect the individual membership. THE COMMITEE RECOMMENDS THE CHANGE AS
  PROPOSED.



# CONNECTICUT UPDATES

In the second quarter of 2025, the Connecticut Federation of Democratic Women (CFDW) remained an active force in advocating for women's rights, civic engagement, and progressive policy.

# Honoring Women!

The Burlington County Federation of Democratic Women (New Jersey) hosted a presentation on the remarkable 6888th Central Postal Directory Battalion at the Burlington County Library on Saturday, June 7th.





The program featured Dr. Karen T. Jordan, who is a Descendant, Historian, and Ambassador of the 6888th Battalion. Dr. Jordon shared memories, personal slides and archival materials honoring her mother, Annie Beatrice Knight — a Savannah native and member of the historic 6888th Central Postal Directory Battalion.

Attendees learned how the courageous women of the 6888th Battalion sorted and delivered millions of pieces of mail during World War II when it seemed impossible. Their inspiring motto was: "No Mail, Low Morale."

The 6888th Central Postal Directory Battalion, known as the "Six Triple Eight" was a groundbreaking all-Black, all-female unit of the U.S. Army during World War II, responsible for managing postal services for American troops in Europe.

It was led by Major Charity Adams (the highest-ranking Black

women in the Army at the time). Their primary mission was to sort and deliver a massive backlog of undelivered mail, some as old as two-years.

### Celebrating Excellence: The NJFDW Peg Roberts Volunteer Awards Luncheon

The New Jersey Federation of Democratic Women (NJFDW) held their annual Peg Roberts Volunteer Awards Luncheon on May 3rd, celebrating the exceptional contributions of women and elected officials who are making a real difference in their communities. Named in honor of volunteer extraordinaire Peg Roberts, this event is a testament to the power of dedication and service.

This year, the awards were presented in four categories: The Peg Roberts Volunteer Service Award, the Outstanding Elected Officials Awards (North, Central, and South), the Loretta Weinberg Lifetime Achievement Award, and the NJFDW President's Award.

### **Honoring Community Leaders**

The Peg Roberts Award was presented to Community Organizer Mary Slomine. Mary currently serves as Emeritus Vice President of the South Jersey Democratic Women's Forum and municipal co-chair of the Atlantic County Democratic Committee (ACDC) in Margate. She has served as a delegate for Barack Obama and was honored with the NAACP President's Freedom Award in 2022 for her resilience and deep commitment to her community.

# History Made on Primary Night in New York

In a landslide, New York State Federation of Democratic Women member and keynote speaker of a recent annual conference, **Dr. Dorcey Applyrs** won a four-way Democratic mayoral primary in Albany on June 24. In this 10-to-1 Democratic city, Applyrs is now on her way to becoming the first Black mayor in Albany's 400 year history. Dorcey's history-making campaign was managed by **NYSFDW President Denise Murphy McGraw**.

**Sharon Owens** of Syracuse also made history by winning her three-way primary last month. The current deputy mayor is now on track to become Syracuse's first black mayor.

# Holding the Line: Democratic Women in Arkansas Face a Session of Extremes

In Arkansas, being a Democrat can sometimes feel like yelling into the wind. Being a *Democratic woman*? That's more like building a shelter in a tornado with nothing but grit, policy, and a folding chair.

The 2025 legislative session in Little Rock has come and gone, and with it, another round of Republican supermajority dominance. Governor Sarah Huckabee Sanders and legislative leaders advanced a hard-right agenda, focused more on national political theater than the daily realities of Arkansans. And yet, despite long odds, the Democratic women of Arkansas refused to sit down or stay quiet.


Because behind every "no" vote, every impassioned floor speech, and every coalition formed, there are real Arkansans who feel seen. Voters who want their voice to count. We do this for them. And we do this with them.

### A Season of Extremes

Let's be honest: Much of the legislation this year was deeply troubling. The GOP pushed bills that attacked reproductive rights, criminalized support for trans youth, restricted immigrant families, and attempted to rewrite the rules of civic engagement. At one point, it felt like every committee room was another front in a culture war we didn't start but were expected to endure.

The Arkansas GOP's priorities this year were clear: limit who can learn, who can vote, who can parent, and who belongs. Democratic women, often outnumbered but never outmatched in compassion or clarity, bore witness to these harms in committee rooms, floor debates, and constituent meetings.

But Democratic women didn't just endure—we organized, questioned, objected, and in some cases, stopped these bills in their tracks.



### The Power of "No"

Democratic women played a key role in defeating legislation that would have had devastating impacts on real people, particularly those already living on the margins.

- A bill that would have allowed lawsuits against doctors, teachers, or even parents who support trans youth? Defeated.
- A proposal to let volunteer chaplains into public schools to "advise" students? **Defeated.**
- Legislation targeting non-citizen Arkansans seeking public services? **Also defeated.**

When these bills died in committee or on the floor, it wasn't magic—it was because Democratic women stood together, asked the hard questions, and demanded the answers the public deserved.

### **Looking Ahead**

This session made it painfully clear that the next fight isn't just in the Capitol—it's in our communities. It's on school boards, in quorum courts, in neighborhood associations, and—yes—at the ballot box in 2026.

We are discouraged. We are angry. We are sad for the immediate future of our state.

But we are also determined, and know the work is not only worth it, it's the right thing to do.

We are organizing. We are recruiting and training candidates. We are mentoring the next wave of young

women ready to run for office or speak truth in rooms they were never expected to enter.

We know the odds. But we also know the power of showing up, again and again, even when the microphones are turned off and the cameras are gone.

Because that's what Democratic women in Arkansas do. We don't just speak. We *build*—even in the storm.


Mississippi Democratic Women Present: We the People - A Community Conversation

# DWNC at 65: Electing Democrats, Empowering Women, Defending Democracy!

The Democratic Women of North Carolina (DWNC)'s 65th anniversary will be featured in our annual convention September 19–21st in Asheville, North Carolina. We continue to be the largest and strongest auxiliary organization for the North Carolina Democratic Party.

Our 2025 DWNC Slogan is "DWNC - for the Will of the People." We base our activities and strategies on our DWNC Mission. Our focus is to provide opportunity for our members that seek leadership in DWNC, or NCDP or elected officials. Our activities and programs are dedicated to electing Democrats to office.

Our NC Supreme Court Associate Justice Allison Riggs won her election on November 6th, 2024. Her opponent demanded two recounts. She won by 734 votes. # Bringing Activism From the Street to the Voting Booth

Greetings Sisters! Indiana is focused on trainings throughout our state this year, in our 92 counties and as a group. We are working to bring women from the activism on the sidewalk to being actively involved in politics.

During these past couple of months, the Indiana Democratic Women have remained deeply engaged in legislative advocacy and civic education. In early May, we hosted a People's Town Hall in Lafayette featuring Indiana Democratic Party Chair Karen Tallian and other state leaders, offering Hoosiers a platform to voice concerns and connect with representatives. Through the Younger Women's Task Force, we also organized weekly Legislative Action Hours via Zoom, empowering members to monitor reproductive justice legislation and directly lobby state lawmakers.

Democratic women in Indiana were also prominent in voter outreach and public demonstrations.

Members participated in People's March rallies in Indianapolis and Lafayette earlier in the spring, and later joined statewide "No Kings" protests opposing authoritarian policies and calling out extremist agendas. We also supported local efforts like Protect Medicaid Day and Trans Day of Visibility events in cities like Indianapolis, Lafayette, and Muncie—as part of a broader protest guide circulated throughout the state.

Together, these activities reflect a robust blend of policymaking, grassroots mobilization, and direct action by Indiana Democratic Women — demonstrating our unwavering commitment to defending Democratic values, amplifying marginalized voices, and helping bring women from the streets to the ballot box.

### We Will Be Heard!

The Oklahoma Federation of Democratic Women has played a prominent role in shaping our party's statewide agenda. Members took part in the Oklahoma Democratic Party State Convention held June 28–29 in Broken Arrow, engaging in breakout sessions, contributing to party platform discussions, and electing new leaders. Members also attended the powerful "Fight Back Luncheon" the evening before, where advocates like Tamya Cox-Touré and Heather Rahhal Palacios rallied participants to "organize, show up, [and] fight like hell" against threats to education, healthcare, and democracy.

In addition, OFDW has sustaining deep grassroots engagement. Through advocacy committees, we tracked bills during the legislative session, participated in Capitol Days alongside allied groups, and initiated voter registration drives to address our state's persistently low turnout. OFDW also connected volunteers with local campaigns, organized phone/text banking, hosted postcardwriting nights, and actively recruited Democratic candidates at local protests and events.

Oklahoma Democratic women across the state have taken to the streets to protest. They joined House Democrat walkouts at the Capitol in March, opposing restrictive abortion and transgender bills and participated in the statewide Hands Off! OKC Rally in early April, mobilizing against Trump-era policies like Project 2025 and actions by Governor Walther. They also gathered at "No Forced Birth" protests in June to oppose forced-pregnancy measures, and engaged in broader resistance rallies on issues such as immigrant rights, education policy, and reproductive freedom.

Through these combined efforts in leadership, advocacy, and community organizing, these past few months have proven to be a dynamic season for OFDW—with protest, policy, and **people power at the forefront**.

The Women's Democratic Club (WDC) of Utah remained highly active and engaged across the state, participating in and organizing a wide range of events and initiatives.

The Club hosted informational tables at numerous rallies and conventions, including the Bernie/AOC Speech on April 13th, the Hands Off Rally on April 19th, "Don't Mourn, Organize" on May 1st, and multiple Democratic State and County Party conventions throughout May, helping to expand visibility and membership which is now at 360.

The Club also **supported key events** like the Orton McKay Fundraiser in Weber County and the Utah Democratic Party's Taylor & Mayne Awards and State Convention in Ogden. In June, WDC partnered with Salt Lake County at the Pride Festival and WestFest, and held a Luncheon on Immigration on June 14th.

### From Santa Fe to the Streets: NMFDW Champions Democracy

The New Mexico Federation of Democratic Women (NMFDW) has sustained its momentum through targeted advocacy, political engagement, and grassroots organizing. We began the year with a powerful Women in Blue Day at the State Capitol in Santa Fe on February 17, 2025, where members from across the state met with legislators to advocate for key issues such as reproductive rights, rural healthcare access, and public education funding. The day was a visible and impactful demonstration of Democratic women's leadership and a strong reminder of our policy priorities.

Throughout the spring, our members have been actively engaged in voter education and fundraising efforts to support Democratic candidates running for statewide office. Currently, three Democrats are in the race for Governor, while the Lieutenant Governor's race features three Democratic contenders—including two women. Additionally, three Democratic women are campaigning to become New Mexico's next Secretary of State. As our state legislature has the second-highest female majority in the legislative body in the entire country, we continue to proudly champion candidates who reflect our progressive values and embrace our state's slogan that "Everybody is somebody in New Mexico".

Our members remained engaged beyond the Capitol by attending the New Mexico Democratic Party's Spring State Central Committee (SCC) meeting on April 26, helping to **shape the party's strategic direction** ahead of the next election cycle and to elect new party officers.

NMFDW members also joined statewide demonstrations such as the "No Kings" rally and "Hands Off" protests, standing in solidarity with national movements to defend democracy, protect bodily autonomy, and oppose authoritarian threats. These efforts reflect our **deep commitment to collective action and civic participation**.

Looking ahead, NMFDW is preparing for a dynamic summer and fall. By building on recent successes and staying mobilized around leaders like Deb Haaland, we continue to shape the future of New Mexico politics—ensuring Democratic women remain a force for progress at every level.
