# Terms and Conditions HTGF Family Day 2026, 11 and 12 May 2026 at STATION Berlin

Status: 9 December 2025

## 1. Scope of the Terms

These General Terms and Conditions govern the legal relationship with regard to the registration and participation at the event "HTGF Family Day" between High-Tech Gründerfonds Management GmbH (hereinafter "organizer") and visitors of the event (hereinafter referred to as "visitor").

#### 2. Conclusion of the contract

The contract to participate in the event is only concluded when using the shared distribution channel using the personal registration code. The time of the conclusion of the contract is governed by the regulations of the distributor. Registration using a foreign registration code is not permitted.

# 3. Registration fee

The registration fee will be due immediately upon conclusion of the contract.

## 4. Cancellation of the registration by the visitor and transfer of the ticket

A cancellation of the registration by the visitor is possible up to four weeks before the event date. Shutdown is on the time of access to the organizer. The entrance fee will be refunded in case of a timely cancellation, minus a cancellation fee of 20% of the entrance fee. In case of late cancellation (less than 4 weeks before the event), a refund of the entrance fee is not possible.

In case of prevention, it is possible to reassign the ticket to a replacement person. This reassignment must be notified to the organizer up to one week before the event.

**For free tickets**, we reserve the right to charge a no-show fee of EUR 150 if the participant does not attend the event and neither cancels the registration at least 10 days before the event date nor nominates a replacement participant by that time.

## 5. Ticket Category Verification and Modification

Participants are encouraged to provide truthful and accurate information during the registration process. By purchasing a ticket for this event, participants acknowledge and agree that the event organizer reserves the right to verify and, if necessary, modify the ticket category based on the accuracy of the information provided during registration. In the event that a participant misrepresents their eligibility for a specific ticket category, the organizer retains the authority to either reassign the participant to the appropriate category or terminate the ticket.

## 6. Consent to the publication of subscriber data

The visitor agrees that his personal participant data (title, name, company, position, industry, area of activity of the company) will be listed on a publicly accessible list of participants after a successful registration. The visitor further agrees that his personal subscriber data will be included in digital databases and data processing programs to which the other visitors of the event have access. The

administration and incorporation of these personal subscriber data may also be carried out by third parties. The visitor can revoke this agreement at any time vis-à-vis the organizer.

#### 7. Liability / Limitation of Liability

The organizer is not liable for damages of the visitor.

This disclaimer of liability does not apply to liability for breach of a material contractual obligation. Significant contractual obligations are those whose fulfilment makes the proper execution of the contract possible in the first place, and on the compliance of which the contracting party may regularly rely on. The disclaimer also does not apply to liability for damages resulting from injury to life, limb or health. It also does not apply to damages that are based on an intentional or grossly negligent breach of duty by the organizer, its legal representatives or vicarious agents.

## 8. Program changes

The organizer reserves the right to change the program of the event if individual speakers cancel participation at the event. In this case he will try in for an adequate replacement. In the case, of short-term cancellations, individual program items may also be cancelled without replacement. The visitor can not derive any claims from the change of program points, as long as the overall character of the event is maintained despite the program change.

## 9. Photos / videos

By registering for this event, the transfer of your name and function within the company is linked to the host of the event.

The visitor agrees that there will be taken pictures and videos of him during the event. The organizer may publish these images/videos for their own public presentation on the Internet, their own social media channels, or in print and use them for any press and public relations work related to the event.

#### 10. House Rules

The organizer has the house right in the context of the event. Arrangements of its employees, which serves to ensure an undisturbed execution of the event or the safety of the visitors and other participants, is result to bars. In case of violations, the organizer reserves the right to exclude visitors from the event.

## 11. Jurisdiction

If both contractual partners are merchants, the exclusive place of jurisdiction for all disputes arising directly or indirectly from the contractual relationship is Bonn.

# 12. Severability clause

If any part of these terms and conditions be or become invalid, the validity of the contract or the remaining terms and conditions shall not be affected. Ineffective provisions shall be replaced by those which come closest to the intended purpose of the parties.
