## 1. Services Provided

- On The Go Golf will provide a mobile golf simulator setup including: hitting bay, turf, impact screen, launch monitor, projector, laptop/software, clubs (men's right handed clubs only (extra golf clubs such as women's, children's, and left handed are an additional charge)) and event staffing. Please inform On The Go Golf upon booking if golf clubs outside the men's right handed are needed.

## 2. Client Responsibilities

- Provide a suitable event space (flat, dry, with access to power).
- Ensure venue approval for simulator setup (including outdoor/indoor clearance (20Wx20Lx11T)).
- Maintain safe conditions for guests.
- Confirm access times for load-in and teardown.

### **4. Cancellations & Weather Policy**

- Client cancellations within 7 days of the event forfeit deposit.
- Weather-related cancellations will follow the On The Go Golf Weather Plan:
  - - Events may continue in covered or indoor locations.
  - - Unsafe weather (lightning, severe storms, high winds, snow) may result in delay, pause, or reschedule.
  - Rescheduling due to weather will be made at no extra cost, subject to availability.

### **5. Safety & Waivers**

- All guests MUST sign a waiver before participating (digital or paper).
- Only one player allowed in the hitting area at a time.
- Children under the age of 16 must have a parent or guardian present at all times. No exceptions.
- Staff reserve the right to pause or stop play for any reason they see fit.
- No food or drink in the hitting area.
- When a person is in the hitting area, all other attendees must be behind the safety line. No exceptions.

### **6. Liability & Insurance**

- On The Go Golf carries general liability insurance.
- Client is responsible for damages caused by guests outside normal use.
- On The Go Golf is not liable for injury resulting from guest negligence or failure to follow safety rules.

### **7. Setup & Teardown**

- Setup requires approximately 1.5–2 hours prior to event start.
- Teardown requires approximately 1 hour after event end.
- Client must ensure safe vehicle and trailer access to setup location.

### **8. Photography & Marketing**

- Unless otherwise requested, On The Go Golf may take photos and videos during the event for marketing purposes.
