## **FUNDING PROVISION FROM SEPTEMBER 2025**

### **Available Funding**

As of September 2025, Little Orchard Day Nursery Ltd will offer funded spaces of up to 30 hours per week for eligible children. This will be for a trial period of up to 12 months while we ascertain whether it is financially viable for the business to continue to offer funded places. However, it will be reviewed on a termly basis during the 12 month period.

### **What is included in the funding for my child?**

The Government provide an hourly funding rate that contributes towards the cost of childcare and education for your child's sessions. While the funded hours are shown as "free" at the point of delivery on your invoice, we charge separately for enhanced services, resources and provisions.

We have created a choice of packages for you to voluntarily choose from. These are shown on the attached Fees and Funding Options table.

### **Term Time Only Funding**

We will continue to offer a small number of term time only contracts primarily for parents who work in education. See attached Fees and Funding Options table (Options E, F, G, H)

### **Stretched Funding**

From September, we intend to offer funding as a "stretched" option to support parents who work year-round. The stretched funding will be offered for 50 weeks of the year (allowing for August and December nursery closures). The weekly allocation of hours using the stretched funding model equates to 11 hours per week (not 15 hours) and 22 hours per week (not 30 hours). ### **Enhanced Resources, Experiences and Food**

At Little Orchard Nursery we go above and beyond the minimum requirements set by the EYFS to ensure that your child receives a rich, engaging and nurturing Early Years experience. By opting into the enhanced resources, experiences and food fee, your child's experiences go above and beyond the minimum Early Years Foundation Stage provision.

*Here are some examples of the enhanced experiences, resources, and provisions we provide to give your child the best possible start. These include, but are not limited to:*

#### **Outdoor Learning & Nature Experiences**

*Outdoor play is essential for children's development, encouraging curiosity, creativity and confidence.*

- *Exploring and taking safe risks in our main garden, forest garden, kitchen garden, baby garden and digging area.*
- *Learning how plants grow from seed to harvest, taking care of plants by watering and weeding, understanding why plants need sunlight, water and care and observing changes in plants and seasons.*
- *Growing our own food and gardening.*
- *Working together.*
- *Sensory exploration - different textures in soil, leaves and seeds.*
- *Mud Kitchens and nature play areas.*
- *Trikes, scooters and bikes*
- *Water play area, sandpits and refilling with sand, bark and gravel in digging areas.*
- *Bug and bee hotels, mini-beast exploration kits and discovering life cycles.*
- *Outdoor learning shelters and covered areas eg canopy, gazebo, tents, hammock*
- *Sun hats, water proofs and wellies provided by the setting.*
- *Outdoor craft activities, e.g. bird feeders.*

- *Grass cutting, weeding and outdoor space maintenance.*
- *Forest School resources and specialist training for fire pit use and tool use.*

### ***Enriched Learning through trips and outings***

*Children love to explore beyond the nursery, and we make sure they have amazing visits to outdoor spaces, local organisations, shops and institutions (e.g. parks, local walks, fire station, St Mary's Church Kington, Turner's Garden Centre, Kington Court, The Garth, Hergest Croft, etc).*

#### **Why this matters to parents and children.....**

The Early Years Foundation Stage requires the minimum provision for learning, development and care. We invest far more than just the minimum, ensuring children have a rich, stimulating, high-quality early years' experience.

Without parents opting into the additional voluntary enhanced resources, experiences and food fee, many of these valuable experiences, trips, learning resources and comforts would not be possible.

Our enhanced resources, experiences and food fee is an optional addition to your funded session.

If you choose to opt out, you will need to provide everything your child needs that is not part of the Early Years Foundation Stage delivery. Your session choices may be limited depending on planned nursery activities. Funded sessions may be changed on a termly basis, subject to availability, **Please see the attached Fees and Funding Options Table and select your option. Please return to us signed and dated.**

#### **Funding Terms and Conditions**

- All hours booked outside of funded hours will be charge at the hourly wraparound rate.
- Unused hours cannot be carried forward from one week to the next.
- 30 hours funding can only be used to access provision for either 8am to 3.30pm (stretched) or 7.30am to 5.30pm (term time only).
- Term time only children must attend for a minimum of 3 full days per week to enable for 30 hours entitlement.
- 30 hours stretched funding children must attend at least 3 short days per week (with the option of wraparound)
- 15 hours funding cannot be stretched (must be term time only) and used to access provision between 8am and 3.30pm over two days per week
- Four weeks notice is required to withdraw a child or change hours.
- Term dates and funding dates are set by Herefordshire County Council. We follow these dates.

#### **Booking a Place**

When booking a space at Little Orchard Nursery you will be required to pay a Registration Fee of £100. This is to cover the cost of administration and settling in visits.

#### **Paying Nursery fees**

We ask that parents pay via BACS on receipt of their invoice. Childcare should be paid for in advance to secure your child's place and allow for staff planning in accordance with OFSTED regulations. We also accept nursery vouchers. Bank details will be within your contract and on the invoices. If a parent has difficulties paying fees on time please communicate in confidence to Ms Hulin who will then come to an agreement as how their child can continue at nursery.

Other terms and conditions are available within your nursery contract.
