Rental Instrument Contract / Policy, Terms, and Conditions

3 month period: Violin \$75.00 Viola \$105.00 Cello \$195.00

7.75% or current local sales tax will be added to these above amounts

Rental outfit includes: an instrument (violin, viola, or cello); a bow; and a case for violin/viola, or a bag for cello.

Rental term consist of one or more 3-month rental periods. Contract commences on the day the contract is signed and made between the Renter and M. & R. Weisshaar & Son. Payment for the initial period of the contract is made by credit card. Payments are due on the first day of each 3-month period, the anniversary. A \$15.00 service fee will be due on the commencement of a rental contract.

Rental Renewals: After the initial payment, all future payments must be made by credit card. Your credit card will be automatically charged on the anniversary of the rental period. A late fee of \$15.00 will apply if payments are late or credit card charges are not approved on due date. If a rental payment is more than 30 days late, an interest charge of 8% will be charged to the outstanding balance.

Instrument Return: Rental contract will continue until instrument is returned to M. & R. Weisshaar & Son. No refund will be made for the first rental period. **Refund will be prorated only after the first rental period.** The Renter is responsible for the return of the Outfit to M. & R. Weisshaar & Son, 1763 Orange Ave., Costa Mesa, CA 92627, during regular shop hours.

Rent Equity: Up to 100% of **the initial 3-month rental period** will be applied to the purchase price if the Renter decides to make a purchase. Rental equity expires after 24 months. Sales tax is not eligible for equity.

Warranty: The warranty covers string breakage within the first week of the Contract, and covers all original defects in workmanship or potential material (as determined by M. & R. Weisshaar & Son) for the duration of the Contract.

Instrument Insurance: M. & R. Weisshaar & Son agrees to indemnify the Renter, subject to a deductible amount of \$100.00 for violins, \$150.00 for violas and \$500.00 for cellos, against accidental loss or total damage to rental property, as determined by M. & R. Weisshaar & Son. Upon commencement of the Contract, the condition of the Outfit will be detailed. The Outfit is expected to return in the same condition when ending the rental Contract. Examples of repair include but are limited to: broken/damaged bridge, cosmetic repair of excessive scratches, chips to varnish or edges, cleaning of excessive rosin or dirt or stickers from instrument, bow, case or bag, excessive hair loss of the bow, bow tip damage, or other more extensive restoration.

Basic Care Expectations:

- Under no condition should the Renter chemically clean or polish the instrument or bow, or have repairs done by another party. Repairs are to be carried out only by M. & R. Weisshaar & Son. Other individuals or shops are not permitted to carry out any repair on any part of the Outfit.
- Violin and bow should be gently wiped with clean soft cloth and the bow loosened after each use.
- All personal property such as stickers, decals, tags, or decorations on cases must be removed prior to the Outfit's return, subject to a \$25.00 cleaning fee
- Rental outfit is not to leave the state of California without written permission of M. & R. Weisshaar & Son.
