

REQUEST FOR FDC MEDIA BANK-O-MATIC PLAN

- (2) The privilege of paying for advertising under this Plan may be revoked by the Company if any check is not paid upon presentation.
- (3) The employment of the Bank-O-Matic Plan shall not be construed as a modification of any of the provisions of the advertising contract except that during the time the plan is in operation the Company shall not be required to give notice of payment becoming due on any of the installments under the plan.
- (4) The payment of advertising under this plan may be discontinued by the Company or the undersigned upon thirty (30) days written notice.

EXPLANATION OF BANK-O-MATIC

NOTE TO FIELD REPRESENTATIVES: Use check list below to be certain all requirements have been considered.

OPENING A NEW BANK-O-MATIC ACCOUNT

- ☐ **Print** full name of the depositor as shown on the banks records, full name of the bank and branch, if any, and address of bank or branch where account is located.
- ☐ **Attach** a specimen check which includes:
 - (1) Correct bank or branch bank transit number
 - (2) Depositor's special checking account number, if required by the bank.
- ☐ Bank-O-Matic checks should be drawn on a regular checking account.
(Most banks will not allow our Bank-O-Matic Plan on "Pay as you check" accounts.)

BANK CHANGE

- ☐ If payor changes banks, submit a fully completed authorization form and new specimen check.

NAME CHANGE

- ☐ If the payor's name is changed, submit a new Bank-O-Matic authorization form.
