**Compensation/Job outlook:** According to the U.S. Bureau of Labor Statistics 2023 report the average median pay for a professional Cosmetologist is \$35,080.00 and professional Aesthetician was \$43,200.00 per year. The employment outlook depends on a wide variety of factors including trends and events affecting overall employment, location, *employment turnover, occupational growth, etc.* Booth rental in the salon or day spa, basic salary and basic salary plus commission, working in a doctor's office and working from home are all choices of employment. Some salons also pay bonus for each year depending on sales volume. Continued growth in the

number of full-service day spas will generate numerous job opportunities. A good professional will be an active listener and be able to identify any problems and/or opportunities for improvements.

**Physical demands of the Profession:** You will typically work in clean, pleasant surroundings with good lighting and ventilation. Longer hours are common in these occupations, especially among self-employed workers. Schedules may include evenings, weekends, and holidays, keeping in mind there are some of the beauty salons and spas busiest times of the year. The beauty industry requires you to have good arm-hand steadiness and to be on your feet many hours of the day.

**Safety Requirements of the Profession:** Certain safety requirements must be followed when working with the public. Inflamed, infected, broken or swollen skin should not be worked on. Infectious diseases must be kept out of the salon. Gloves, protective eyewear, and protective clothing should be worn when chemicals are being worked with.

**Licensing Requirements:** All students at Austin's must be at least 16 years of age and have a High School or have a High School or GED High School Equivalent (with the exception of an instructor trainee). An instructor Trainee must be 18 years of age and have a high school diploma or GED High School Equivalent and have a valid Tennessee Cosmetologist License for 3 consecutive years in the field. You must submit to the board that you have received training in an approved school for hours required (cosmetology 1500, Aesthetician 750, instructor 300, Manicuring 600). After posting the required testing fees you will then be scheduled a test date to begin your boards. Boards are given in Nashville, Knoxville, and Memphis, Tn... There is reciprocity with other states, but you will need to **investigate** the specific state requirements if you wish to practice elsewhere. **After graduation, to obtain a State license, you must take the required State Board tests (a one-time test fee for the theory exam and a one-time test fee for the practical exam shall be paid by the school. Any additional test fees shall be paid by the student). When all requirements/test are passed, you must submit proof of required state domestic violence training certificate and pay the current state license fee for your individual license.**
