BASIC PROFESSIONAL SERVICES OF FUNERAL DIRECTOR AND STAFF \$ 1800.00

Consultation with family or responsible party; determination and planning of services desired; coordinating and scheduling with clergy, cemetery, crematory, or other parties involved; preparation and filing of necessary documents; obituary formatting and submission to publications (*does not include the newspapers charges to run the notice*). This includes a proportionate share of basic overhead costs.

Except in certain cases, embalming is not required by law. Embalming may be necessary if you select certain funeral arrangements, such as a viewing.

~CASH ADVANCES~

Cash Advances are outside charges for services and expenses that are incurred in conducting the desired arrangements. These can consist of, but are not limited to; offering for clergy, organist, other musicians, soloist, church sexton, florists, hired pall bearers, cemetery grave opening charges, grass and device for grave set up, cemetery tent, crematory, State Medical Examiner's fee, certified copies of the death certificate, newspaper charges, disinterment permit and related fees, cemetery or vault company overtime charges, and any other outside charges that are incurred in conducting the arrangements. These fees will be added into the funeral service contract, as well as a minimum \$7.25 fee should we need to mail certified copies to the next of kin, at their request.

As a convenience to families and because many of the outside vendors do not accept personal checks, the Funeral Home will pay these advances and list the charges on the funeral bill under Cash Advances.

* Death certificates provided on the electronic database will reflect the convenience fees charged by the state as follows: The Medical Examiner's Cremation Clearance fee will be \$154.95. The certified copies of the death certificate will include a convenience fee of \$7.80.
