



CAT BOARDING AGREEMENT

Thank you for choosing **ELITE PAWS PET RESORT** for your pet boarding and cat needs.

Requirements: All felines will need **FVRCP** and **Rabies**. Official updated vaccination records must be provided prior to entry into boarding and must be administered at least 3 days prior to either service. We reserve the right to refuse to accept a pet at check in for any reason including, without limitation, if it appears to us that the pet is sick, injured, in pain or that its behavior could jeopardize the health or safety of other pets or our staff. If your pet has a medical condition or is on any medication please see staff so they can evaluate the pet's condition.

1. Emergency Contact:

You have the option to name an adult (over the age of 18) as your agent or emergency contact. This person should not be someone traveling with you if you are leaving town. If we cannot reach you, you authorize us to contact your agent. You agree that your agent shall have your full and complete authority to make any and all decisions, including those related to the health of your pet and the expenditure of funds, for or on behalf of you and your pet.

2. Emergencies:

If your pet has what our employees deem, in their sole and absolute discretion, to be an emergency illness or injury during their visit, and we are unable to reach you or your emergency contact, we will take your pet to the emergency vet, and you will be responsible for any and all veterinary bills incurred.

3. Liability:

You acknowledge and agree that in the unlikely event your pet is injured by another pet you release ELITE PAWS PET RESORT and its, owners, employees, and agents from any and all liability and financial responsibility for such injury. If your pet injures another pet, you will be solely responsible for any damage or injury to the other pet(s) as well as your own pet, and you agree to release ELITE PAWS PET RESORT and its owners, employees, and agents from any liability and financial responsibility for such injury. You understand that it is possible for a pet to become ill even if vaccinated. You assume all the risks and accept the responsibility for all treatments costs. You further agree to hold the owner and employees of ELITE PAWS PET RESORT during his/her stay with us, you acknowledge and agree that you will be responsible for charges incurred to replace such items.

4. Veterinary Costs:

In addition to the emergency terms as outlined above, you agree to allow ELITE PAWS PET RESORT to obtain veterinarian medical treatment for your pet, if, in its sole discretion and absolute it appears that, the pet is ill, injured, or exhibits any other behavior that would reasonably suggest that your pet might need medical treatment. Medical treatment may require transportation of my pet to receive care and I

hereby authorize such transportation. You grant ELITE PAWS PET RESORT full authority to make decisions involving the medical treatment of my pet during its stay at ELITE PAWS PET RESORT. You agree that you are fully responsible for the cost of any such medical treatment and transportation.

6. Unfortunate Event:

At ELITE PAWS PET RESORT, we strive to provide the very best in loving care for your pet(s) while they are at our facilities. Sometimes, sadly, incidents occur that are out of our control. In the unfortunate event that your pet should passed away while in the care of ELITE PAWS PET RESORT, your pet will be taken to our veterinarian and held at your cost until arrangements can be made.

8. Personal Items:

Do not bring items with your pet that are valuable or irreplaceable. ELITE PAWS PET RESORT is not responsible for loss or damage to personal items or toys left with your pet.

All medications must be in a container with a current prescription label from your veterinarian. Supplements not labeled for animals or prescribed by a veterinarian will only be given with your permission and you assume responsibility for their use.

9. Pets Not Picked Up on Departure Date/Abandoned:

If you or your agent does not pick up your pet at the agreed time, you hereby authorize us to continue to provide the services as set forth in this agreement at your expense. If the pet is deemed abandoned under local, state, or federal laws ELITE PAWS PET RESORT will attempt to contact you by telephone and/or in writing advising you that if your pet is not picked up within a reasonable time period your pet will be delivered to a third-party adoption partners, animal control, the Pueblo County Humane Society, or other similar government agency. You understand that you may lose ownership of your pet under the circumstances. If you fail to pick up your pet for any reason, you release ELITE PAWS PET RESORT from all further liability and responsibility for your pet. You shall remain liable to us for all unpaid charges, including the court costs and reasonable attorney's fees incurred in the collections of the charges.

10. Payment for Services:

You agree to pay ELITE PAWS PET RESORT for the service we provide to your pet during each visit at the rates set forth at the start of such visit. Charges begin on the day you leave your pet. If you do not pay your bill in full at check-out ELITE PAWS PET RESORT may retain custody of your pet at your expense until the bill is paid in full.

11. Cancellation and Early Pickup Policy:

- Cancellations made seven days or more prior to boarding: **There will be no charge.**
- Cancellations made four to six days prior to boarding: **Fifty percent of the boarding fee will be charged.**
- Cancellations made three days or less prior to boarding: **The full boarding fee will be charged.**
- Early Pick Up: **If you pick your pet up early, the full boarding fee will still be charged.**

12. Miscellaneous Provision:

This written agreement constitutes our entire and only agreement and there are no oral agreements or understandings except as provided for in this agreement. We reserve the right to use photographs or video footage of your pet taken during their stay. These images may be used for marketing materials, either in print form or on the internet. This agreement will remain in effect for any current or future pets you may bring to ELITE PAWS PET RESORT until the time it may be updated.

13. Termination:

Either ELITE PAWS PET RESORT or the pet owner may terminate this Agreement at any time by providing notice to the other. Upon termination, owner will immediately pick up pet(s) and pay all charges that are due. ELITE PAWS PET RESORT also may terminate this Agreement at any time, if ELITE PAWS PET RESORT, in its sole discretion, determines that the pet(s) poses a danger to the health and safety of any person and/or animal.

14. WAIVER, RELEASE, AND INDEMNIFICATION. I RELEASE, WAIVE, DISCHARGE, INDEMNIFY AND AGREE TO HOLD ELITE PAWS PET RESORT, ITS OWNERS, DIRECTORS, OFFICERS, EMPLOYEES AND AGENTS HARMLESS FOR ANY AND ALL MANNER OF DAMAGES, INJURY, CLAIMS, LOSS, LIABILITIES, COSTS OR EXPENSES, ATTORNEY'S FEES, CAUSES OF ACTION OR SUIT, WHATSOEVER IN LAW OR EQUITY, ARISING OUT OF OR RELATED TO THE SERVICES PROVIDED BY ELITE PAWS PET RESORT, ITS OWNERS, DIRECTORS, OFFICERS, EMPLOYEES OR AGENTS INCLUDING WITHOUT LIMITATION: (1) ANY INACCURACY IN ANY STATEMENT MADE BY MYSELF OR INFORMATION PROVIDED BY ME TO ELITE PAWS PET RESORT, (2) MY PET, INCLUDING BUT NOT LIMITED TO DESTRUCTION OF PROPERTY, DOG BITES, INJURY, AND TRANSMISSION OF DISEASE, AND (3) ANY ACTION BY MYSELF THAT IS IN BREACH OF THE TERMS OF THIS AGREEMENT.
