"Rush for Gold" Gold Bullion Raffle Terms & Conditions

These Terms and Conditions ("T&Cs") apply to the Mafra Community Sports Club Inc Gold Bullion Raffle ("Rush for Gold"), conducted in accordance with the Gambling Regulation Act 2003 (Vic), Gambling Regulations 2015 (Vic), and the Victorian Gambling and Casino Control Commission (VGCCC) guidelines for raffles and minor gaming.

Important Note:

This promotion is a Raffle (Minor Gaming Activity), not a Trade Promotion Lottery, as tickets are being sold directly.

1. Promoter and Eligibility

1.1 **Promoter:** Mafra Community Sports Club Inc, 122–126 Johnson Street,

Mafra VIC 3860.

1.2 Authorisation: The Raffle is conducted under the Club's existing Minor Gaming

Authorisation as a registered community club.

1.3 Eligibility: Entry is open to Victorian residents aged 18 years or over,

including members and non-members of the Mafra

Community Sports Club Inc.

1.4 Exclusions: Employees and agents of the Promoter, their immediate family

members, and any person prohibited by law are not eligible to

enter.

2. Promotion Period and Draw Details

2.1 **Ticket Price:** AUD \$10.00 (including GST) each.

2.2 Opening Date: 10:00am, Saturday 1 November 2025.

2.3 Closing Date: 6:00pm, Friday 6th February 2026.

2.4 **Draw Date:** 8:00pm, Friday 6th February 2026.

2.5 Draw Location: Mafra Community Sports Club, 122 - 126 Johnson Street,

Mafra VIC 3860.

2.6 **Draw Method:** The draw will be conducted at random from all valid tickets in

the presence of two (2) Club representatives. Each valid ticket

has an equal chance of winning.

3. Entry Conditions

3.1 Entry is obtained by purchasing a ticket during the rafle period at the Club.

- 3.2 Tickets may only be purchased within Victoria.
- 3.3 Entrants must be 18 years or older at the time of purchase.
- 3.4 Entry is **not** conditional upon playing a gaming machine, participating in gaming-related promotions, or using loyalty points.
- 3.5 Any additional entry costs (e.g., postage, SMS) will not exceed AUD \$1.00 including GST, if applicable.
- 3.6 The Promoter reserves the right to declare any ticket invalid if it is forged, mutilated, altered, or tampered with in any way.

4. Prize Details

- 4.1 Prize: One (1) prize consisting of Two (2) Troy Ounces of Gold Bullion.
- 4.2 **Approximate Retail Value:** AUD \$11,500 (subject to gold market fluctuations at the time of draw).
- 4.3 The prize is non-transferable and not exchangeable for cash.
- 4.4 If the advertised prize becomes unavailable due to circumstances beyond the Promoter's control, a substitute prize of equal or greater value will be offered, subject to the winner's written consent.
- 4.5 The prize will be delivered to the winner within 28 days of the draw date by a Club committee member and venue team member.
- 4.6 No additional fees or costs will be incurred by the winner to claim or receive the prize.

5. Winner Selection and Notification

- 5.1 The winner will be selected randomly from all valid entries.
- 5.2 Entrants do not need to be present at the draw to be eligible to win.
- 5.3 The winner will be notified in writing and/or by email within five (5) business days of the draw, using the contact details provided on the ticket.
- 5.4 The winner's name and suburb will be published on the Mafra Community Sports Club website for a minimum of 28 days after the draw.
- 5.5 The winner must provide valid photo identification (e.g., driver's license, passport) prior to prize handover.
- 5.6 The winner must sign a Prize Receipt Acknowledgement confirming receipt and condition of the prize.

6. Unclaimed Prizes

6.1 If the prize remains unclaimed after three (3) months from the original draw date, a redraw will occur.

- 6.2 The redraw will be conducted at the same location, under the same conditions as the original draw.
- 6.3 The redraw winner will be notified and published in accordance with Clause 5.
- 6.4 All redraws will comply with applicable VGCCC Raffle requirements.

7. Identification, Delivery, and Verification

- 7.1 The winner must present valid identification to confirm eligibility and identity before the prize is awarded.
- 7.2 The prize will be securely delivered to the winner's nominated Victorian address within 28 days of the draw.
- 7.3 The prize handover will be witnessed by a committee member and a venue team member.
- 7.4 The Club's Anti-Money Laundering / Counter-Terrorism Financing (AML/CTF) program applies.
- 7.5 Identity verification (KYC) will be performed, and any necessary reports will be lodged with **AUSTRAC** due to the high-value gold bullion prize.

8. Liability and Disclaimers

- 8.1 The Promoter accepts no responsibility for lost, stolen, damaged, or late entries.
- 8.2 The Promoter is not liable for any technical or communication failures affecting entry or draw processes.
- 8.3 To the maximum extent permitted by law, the Promoter disclaims all liability for any loss, injury, or damage (including negligence) arising from participation in the raffle or the use of the prize.

9. Privacy and Data Use

- 9.1 The Promoter collects entrants' personal information (name, address, contact details, and ticket number) solely for the purposes of administering this raffle.
- 9.2 Personal information will not be used for any other purpose, unless required by law.
- 9.3 By entering, participants consent to their name and suburb being published for the purpose of prize notification and transparency.
- 9.4 The Promoter complies with the Privacy Act 1988 (Cth) and the Club's Privacy Policy, available on the Club's website.

10. Record-Keeping and Compliance

10.1 The Promoter will maintain accurate records of ticket sales, draw results, and prize distribution for a minimum of three (3) years after the raffle concludes.

10.2 The raffle will be audited and reviewed in accordance with VGCCC Minor

Gaming requirements.

10.3 Any amendments or cancellations of this rafle will be made only as required by law or under direction from the VGCCC.

11. Governing Law

- 11.1 These Terms and Conditions are governed by the laws of the State of Victoria, Australia.
- 11.2 Any disputes arising in relation to the rafle will be subject to the exclusive jurisdiction of Victorian courts.
