

The '***Spin to Win Wednesdays***' Promotion
Maffra Community Sports Club
Every Wednesday from 5pm
TERMS AND CONDITIONS OF ENTRY

1. Terms and Conditions: These Terms and Conditions of Entry include information on how to enter and prizes. Participation in the '***Spin to Win Wednesdays***' Promotion ("Promotion") is deemed acceptance of these Terms and Conditions of Entry.
2. Participating venue: The Promotion is only available at The Maffra Community Sports Club, 122-126 Johnson Street, Maffra, Victoria ("Venue"). The Promotor is Maffra Community Sports Club Inc ("Club").
3. Eligibility: Entry is open only to members of the Club who are over 18 years of age. Entry is not open to employees of the Club.
4. Draw Nights: Prize Draws will take place at the Venue immediately after the raffles, approximately 7.45pm-8pm every Wednesday.
5. How to enter:
 - a) It is not a precondition to entry to the Promotion that you play a gaming machine or participate in a loyalty scheme that requires expenditure on gaming machine play or agree to receive gaming machine advertising.
 - b) To enter members must swipe their membership card at the Club Mix Rewards Kiosk between 5.00pm and 7:30pm on Wednesdays to receive an entry tickets and deposit those tickets into the entry barrel, at the Venue, before the raffles end on that night. (The tickets will have the member's name and membership number printed on them).
 - c) The number of entry tickets received will be dependent on the member's tier level as follows:
 - Members on Opal Level will receive one entry ticket
 - Members on Ruby Level will receive two entry tickets
 - Members on Sapphire Level will receive three entry tickets
 - Members on Diamond Level will receive five entry tickets
 - d) All tickets deposited in the entry barrel before the end of the raffles on each of the Draw Nights will be included in the Prize Draw for that night and will be eligible to win a Prize.
6. Prize Draws: The Prize Draw will be conducted at the Venue and will commence immediately after the raffles on Wednesdays. One ticket will be randomly drawn from the entry barrel, the name of the member whose ticket is drawn will be announced, and that member has one minute after the announcement to come forward to spin the wheel. Members must be present and show their membership card or other suitable identification, as determined by the Club. If that member does not come forward a new name will be selected from the barrel until a member who is present acknowledges their selection and spins the wheel.
7. Prize: Each segment of the spinning wheel will be allocated with prizes as follows: 1x Jackpot, 1x \$100 venue voucher, 2x \$50 venue voucher, 11x \$25 venue voucher, 25x free house drink, 5x MCSC cap (hat), 5x MCSC stubby holder. The member whose name is selected from the Prize Draw will be asked to spin the wheel and their prize will be awarded in accordance with the prize of the segment that the spinning wheel stops.
8. Jackpot Prize: The Jackpot prize money will be reset to \$1000 on the 1st Wednesday of each month and subsequently increase by \$250 each Wednesday until it is won. On the last Wednesday of every month, the jackpot must be won, 10 new segments will be added to the wheel which denote JACKPOT and names will be chosen out of the barrel to spin the wheel until it is won. If the Jackpot is won before the last Wednesday of the month, the subsequent Wednesday Jackpots will be \$250 each until the reset at the start of the month.
9. Delivery: The prize won will be allocated to the member as soon as possible after the conclusion of the spin.
10. Publication: The name of the winners may be published on the Club's Facebook page for a period of not less than 28 days as soon as practicable at the conclusion of the Prize Draw.

11. Valid Entries: Only valid tickets issued by the Club will be accepted into the Prize Draw. Tickets are void if stolen, forged, mutilated, photocopied or tampered with in any way.
12. No waiver: Failure by the Club to enforce any of its rights at any stage does not constitute a waiver of those rights.
13. Club's decision final: If there is a dispute concerning the conduct of the Promotion, the Prize Draw or the awarding of the Prizes, the Club's decision will be final and no correspondence will be entered into.
14. Cancellation / delay / modification: If, for any reason whatsoever, any part of the Promotion, the Prize Draw or the awarding of the Prizes is not capable of running as planned, the Club reserves the right to cancel, terminate, delay, relocate, modify, or suspend any or all of elements of the Promotion, the Prize Draw or the awarding of the Prizes, subject to the written directions from any regulatory authority.
15. Privacy: Personal information collected for the Promotion will be used for the purpose of conducting the Promotion and may also be used for the purpose of promoting our products, services, events and future promotions conducted by the Promoter. By entering this Promotion, you consent to this treatment of your personal information. All entries become the property of the Club. The Club complies with the Australian Privacy Principles. To gain access to your personal information held by the Club phone or write to the Club at the Venue.
16. Publicity: Players consent to the Club using their name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of advertising the Promotion and promoting any of the Club's products or services.
17. Limitation of liability: Except for any liability that cannot be excluded by law, the Club, its employees and agents, will not be liable for any loss, damage or personal injury whatsoever (including negligence), which is suffered, incurred or sustained in any way in connection with the Promotion.
18. Governing law: The laws of the State of Victoria govern the Promotion.
