U.S. Aluminum, Inc. manufacturer of Hydro Flo, warrants to you, the original purchaser of Hydro Flo that under normal use and conditions, the product will be free from defects for a period of 25 years from the date of installation. This warranty is transferable.

HYDRO FLO STAINLESS STEEL MESH PANEL 25 YEARS

Hydro Flo's panel will be free from manufacturing defects for a period of 25 years. This warranty is transferable.

LIMITATIONS

U.S. Aluminum warrants only the manufacturing defects on the panel. U.S. Aluminum is not responsible for circumstances beyond its control, such as (but not limited to), improper installation, accident, hail, fire, flood, explosion, wind-blown objects, salt spray, harmful chemicals, abuse, vandalism, or improper maintenance. U.S. Aluminum is not liable for any incidental or consequential damages resulting from any defect or expenses except as expressly provided herein. This warranty gives you specific legal rights; you may have other legal rights which may vary from state to state.

This warranty covers material only. U.S. Aluminum will assume no other expenses such as labor costs for removal or re-installation. U.S. Aluminum will pay all shipping costs related to failure of the product.

CLAIM PROCEDURE

You must promptly notify U.S. Aluminum, in writing, of any manufacturing defect following its discovery at: 4300 N. 124<sup>th</sup> Street, Wauwatosa, WI 53222, Attn: Warranty Department.

Include with each claim a copy of the original warranty and a copy of the contract with the installing contractor, and three photos of the failing product. If U.S. Aluminum cannot determine whether or not the product has failed by examining the photos, it may require a section of the product to be sent to the above address. U.S. Aluminum will pay all shipping costs related to the failure of the product.

WARRANTY REGISTRATION

Failure to register the warranty does not void the warranty, but assists U.S. Aluminum in processing any warranty claims you may have.
