**BASIC PROFESSIONAL SERVICES AND FUNERAL DIRECTOR & STAFF** \$ 3,950.00

This is the basic charge to each family which we serve for our professional expertise in assisting them. It includes, but is not limited to, a proportionate share of the taxes, licenses, utilities, and business expenses necessary to serve the public in a professional manner. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.)

**EMBALMING** \$ 995.00

Embalming is a chemical process which provides temporary preservation and sanitation of the body and eliminates health hazards to the public. A person licensed by this state must complete this procedure. Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

**SPECIAL AUTOPSY CARE** \$ 500.00

In the event an autopsy or organ donation is performed, additional embalming techniques need to be employed. This is the charge for those additional techniques.
