ADDITIONAL INFO:

1. SD number must be used as a reference for all payments made.
2. Fees are payable in advance on or before the first of every month.
3. To qualify for the annual upfront discount, fees need to be paid in full by the 15th January 2024.
4. Late payment penalties may be levied against your account for late payment.
5. Should the annual upfront plan be selected by the fee payer during the registration process, but the full annual amount not paid by the 15th January 2024, this will result in the account being automatically defaulted to the 10 monthly plan with the monthly instalment becoming due immediately.
6. Sibling discounts note: Only siblings within the same school, or within the same brand, will be eligible for a sibling discount. Should a sibling transfer out of the brand in the current year, the sibling discount will be adjusted accordingly or may even cease from date of transfer.
Sibling discounts will be applied as follows to eligible siblings: 5% for the first sibling, 10% for the 2nd sibling and 15% for the 3rd sibling. Please contact your school for any queries in this regard.
7. Compulsory camps as communicated by the school will be billed directly to your child's statement.
