Program Terms And Conditions

1. Based on the size of the grower's corn planter, ALPINE will rebate \$150.00 per row per year for three years. *ALPINE DSM must verify the number of rows on the planter with an on-farm visit.*
2. Maximum rebate is \$450.00 per row, or value of equipment purchased, whichever is less.
3. Rebate will be paid directly back to the grower after original invoices are submitted (*Dealer sales reports are not acceptable*).
4. Precision Planting® equipment that qualifies for the rebate:
 - a. 20/20® monitor
 - b. FurrowJet®
 - c. Smart Firmer®
 - d. Conceal®
 - e. vApplyHD®
 - f. FlowSense™
 - g. EM FlowSense™
 - h. EMHD®
5. Rebates will be calculated based on purchases of ALPINE G22® and/or ALPINE K19-S® and ALPINE K24®:
 - a. ALPINE G22®– \$0.05 per litre
 - b. ALPINE K19-S®– \$0.10 per litre
 - c. ALPINE K24®– \$0.10 per litre
6. For the 2026/27 program, fertilizer purchased between August 1, 2026 through June 30, 2029 will qualify for the rebate.
7. Minimum yearly qualifying purchase– 10,000 litres total of ALPINE G22 and/or ALPINE K19-S and ALPINE K24 in a maximum 4:1 ratio. A minimum of 1 litre of ALPINE K19-S and/or ALPINE K24 must be purchased for every 4 litres of ALPINE G22 to qualify for the rebate program.
8. For the 2026/27 program, equipment purchases made from January 1, 2026 to March 31, 2027 will qualify. Original invoices for equipment will need to be submitted to calculate maximum rebate.
9. Fertilizer invoices and completed Equipment Rebate Form are to be submitted by July 20th of each year.
10. Rebate payments will be made by September 30th of each year.
11. Customer's account with ALPINE (if applicable) will have to be current and in good standing before rebate cheque is issued.
12. Growers can only be on one program at any given time. (i.e. If additional equipment is purchased in year two or three, then it will only increase the maximum payout of the original program.)
