# MEMORANDUM

### **Calls for Service of Significance:**

In January 2026, MCSO responded to 261 calls for service in Perry Township.

On January 18, 2026, at approximately 2002 hours, Trotwood Police Department responded to an Aggravated Robbery complaint at 60 Pinewood Circle. Trotwood Officers identified the suspect as Deleon Bass. Bass also had an active warrant through MCSO for Domestic Violence out of Vandalia Municipal Court with a caution for being armed and dangerous with violent tendencies. Bass also has a previous Aggravated Murder charge against a Law Enforcement Officer. He fled the scene prior to the arrival of officers in a white, Nissan Altima.

At approximately 2140 hours, Trotwood Officer Collins observed a white Nissan Altima traveling westbound on Wolf Creek passing Diamond Mill at over 100 MPH. Officer Collins attempted to catch up and observed the vehicle crashed into some trees around S. Wolf Creek and Heeter. Officers from multiple agencies responded to set up a perimeter and assist with locating the suspect. The suspect was eventually located in the tree line. He was removed to the hospital for evaluation and then booked into the Montgomery County Jail.

### **Community Concerns:**

- PRR for February ref a personnel file from PD has been completed
- PRR for LE emails are completed but waiting on further instruction from Requester

### **Goals and Objectives:**

- The 3-year MOU language and cost estimates for 2026 through 2028 for MCSO to provide part time LE services to Perry Township. This was completed and signed off on by Perry Twp Board of Trustees.
- Tasers purchased by Perry Twp. Have been moved over and put on Perry Twp inventory to be used by deputies assigned to Perry Twp.
- Both Durango's has being serviced and are in the process of being marked up with Sheriff logos. As soon as we can switch over the titles they will be utilized only in Pery Twp for patrol duties.

**Financials:**

Financials did not close for January at the time this report was completed. Perry Twp. Was also just invoiced for January and February LE services, so payroll is currently being pulled from the 2025 carryover.
