MEMORANDUM

Calls for Service:

Perry Twp Crews responded to 122 Calls for service in the month of April with 316 COP (Community Oriented Policing) entries. This includes 113 Incidents, 3 crash investigations, 7 reports generated, 51 traffic stops, 6 citations issued, 0 arrests. There were no significant calls for service that required notification to the Perry Twp. Trustees.

Community Concerns:

May 12th will be the MCSO IMPACT meeting for the residents of Perry Twp. Before the regular scheduled Trustee meeting. (1700-1800)

PRR assist by securing multiple reference material for Perry Twp from the old Chief's Office for Montgomery County Prosecutors to review and redact prior to release.
