MEMORANDUM

Calls for Service:

Perry Twp Crews responded to 186 Calls for service in the month of March with 233 COP (Community Oriented Policing) entries. This includes 82 Incidents, 2 crash investigations, 10 reports generated, 31 traffic stops, 5 citations issued, 1 Felony arrest and 1 Misdemeanor arrests. There were no significant calls for service that required notification to the Perry Twp. Trustees.

Community Concerns:

Old PRR for LE emails are completed but waiting on further instruction from Requester. *No response as of this report. Data is on a thumb drive but cannot access data to review.*

New Public Records Request came in and has been completed.

Vacant House Check Log has been uploaded to the Evertel platform (internal communication software) so all deputies working in Perry Township can see.

Requesting a date in May to conduct the MCSO IMPACT meeting for the residents of Perry Twp.

Goals and Objectives:

Still working on getting: RAM to update MDT's and modems to place the 2 Durango's in service. This should be completed by mid-month.

Financials:

March 2026 closed with the monthly expenditure of \$40,138.05 leaving a balance of \$498,736.99 against the contract. All financial reports were sent to Trustee Heeter and Fiscal Officer Hoover.
