PROPOSED AMENDMENT TO THE CURRENT COVENANTS

Election to approve the Amendment and Restatement of Declaration of Covenants, Conditions, Restrictions and Easements for Kelsey Park Subdivision.

Current Wording:

Section 6.05 (g)..." Each dwelling constructed on any Lot in Eastwick shall contain a minimum of one thousand eight hundred (1800) square feet of air-conditioned flow area, exclusive of all porches, garages, or breezeways."

Section 6.05 (g) of the Declaration is hereby amended and the following section replaces in its entirety as follows:

Proposed Wording:

6.05 (g) Each dwelling constructed on any Lot in Eastwick shall contain a minimum of one thousand, eight hundred (1800) square feet of air-conditioned floor area, exclusive of all porches, garages or breezeways. Provided however, each dwelling constructed on Lots 120 through 129, Lots 132 through141 and Lots 159 through 168, inclusive, shall contain a minimum of one thousand five hundred (1500) square feet of air-conditioned floor area, exclusive of all porches, garages or breezeways
