WHEREAS, certain tracts, consisting of tracts of land set forth herein (the "Annexed Property"), are currently within the territory of Tarrant County Emergency Services District No. 1 ("District"); and,

WHEREAS, the Annexed Property was annexed by the City of Fort Worth (the "City"), the City sent notice to the Secretary of the District of the annexation of the Annexed Property by the City in compliance with and pursuant to Section 775.022, Health & Safety Code and other applicable law, and the City is currently providing fire protection and emergency services to the Annexed Property; and,

WHEREAS, the City annexed certain territory in the District under Ordinance No. AX-25-001, attached hereto as Exhibit A, and removed said territory from the territorial limits of the District; and,

WHEREAS, the District, pursuant to Section 775.022(a), Health & Safety Code and other applicable law, shall immediately change its records to show that the Annexed Property has been disannexed from the District and shall cease to provide further services to the residents of the Annexed Property; and,

WHEREAS, the Board of Emergency Services Commissioners of Tarrant County Emergency Services District No. 1 has determined that it currently has no bonded or other indebtedness requiring the City to compensate the District, or real or personal property used to provide emergency services in the territory disannexed requiring the City to purchase same from the District at fair market value under Section 775.022, Health & Safety Code:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EMERGENCY SERVICES COMMISSIONERS OF TARRANT COUNTY EMERGENCY SERVICES DISTRICT NO. 1:

#### **SECTION 1.**

The recitals set forth above are true and correct and are hereby declared findings of fact and conclusions of law by the Board of Emergency Services Commissioners.

#### **SECTION 2.**

That the President and other appropriate officers of the Board of Emergency Services Commissioners are hereby authorized to execute this Order and take any further actions necessary to effect the release and disannexation of the Annexed Property from the jurisdiction of the Tarrant County Emergency Services District No. 1 pursuant to Section 775.022, Health & Safety Code, and said Annexed Property is hereby released and disannexed by the District and becomes part of the City as set forth in the above-referenced section and other applicable law as of the date of annexation by the City of Fort Worth, Texas as of the date shown in Exhibit A.

#### **SECTION 3.**

A copy of this order shall be filed with the official records of Tarrant County Emergency Services District No. 1, forwarded to the Chief Appraiser of the Tarrant Central Appraisal District, the Tarrant County Tax Assessor-Collector, and other necessary individuals or entities, and said entities or individuals are hereby ordered to revise their respective records to reflect the release and disannexation of the Annexed Territory from the District and into the City as described herein.

The Board of Emergency Services Commissioners of the District hereby finds and declares that written notice of the date, hour, place and subject of the meeting at which this Resolution was adopted was posted and that such meeting was open to the public as required by law at all times during which this Resolution and the subject matter hereof were discussed, considered and formally acted upon, all as required by the Open Meetings Act, Chapter 551, Texas Government Code, as amended.

AN ORDINANCE **DECLARING** CERTAIN **FINDINGS**; PROVIDING FOR THE EXTENSION OF CERTAIN BOUNDARY LIMITS OF THE CITY OF FORT WORTH; PROVIDING FOR FULL-PURPOSE ANNEXATION OF A CERTAIN 4.537 ACRES, MORE OR LESS, OUT OF LAND SITUATED IN THE J.J. ALBIRADO SURVEY, ABSTRACT NUMBER 4, CITY OF FORT WORTH E.T.J., TARRANT COUNTY, TEXAS, BEING ALL OF TWO TRACTS OF LAND DESCRIBED BY DEED TO OLD GRANBURY HOLDINGS, LLC, RECORDED IN INSTRUMENT NUMBER D224199629 (TRACT 1 AND TRACT 2), COUNTY RECORDS, TARRANT COUNTY, TEXAS (CASE NO. AX-25-001) WHICH SAID TERRITORY LIES ADJACENT TO AND ADJOINS THE PRESENT CORPORATE BOUNDARY LIMITS OF FORT WORTH, TEXAS; PROVIDING THAT THIS ORDINANCE SHALL **EVERY** PRIOR ORDINANCE IN CONFLICT AMEND HEREWITH: PROVIDING THAT THIS ORDINANCE SHALL BE **CUMULATIVE OF ALL PRIOR ORDINANCES NOT IN DIRECT** CONFLICT; PROVIDING FOR SEVERABILITY; AND NAMING AN EFFECTIVE DATE.

WHEREAS, the City of Fort Worth has received a petition in writing from owner, Old Granbury Holdings, LLC, requesting the full-purpose annexation of 4.537 acres of land as described in Section 1, below (the "Property"); and

WHEREAS, the hereinafter described Property is in the City's exclusive extraterritorial jurisdiction and is adjacent to and adjoins the City; and

WHEREAS, Subchapter C-3 of the LGC permits the City to annex an area if each owner of land in an area requests the annexation; and

WHEREAS, in accordance with Subchapter C-3 of Chapter 43 of the Texas Local Government Code, the City section 43.0672 of the Texas Local Government Code Old Granbury Holdings, LLC, and the City negotiated and entered into a written agreement, City Secretary Contract No. \_\_\_\_\_\_, for the provisions of municipal services in the area; and

WHEREAS, the City conducted one public hearing at which members of the public who wished to present testimony or evidence regarding the Municipal Service Agreement and Full-Purpose Annexation were given the opportunity to do so, in accordance with the procedural requirements of Section 43.0673 of the Local Government Code on May 13, 2025, at 6:00 p.m., at the City Council Chamber; and square footage in the descriptions; and

WHEREAS, the City Council finds and determines that annexation of the Property

hereinafter described is in the best interest of the citizens of the City of Fort Worth and the owners and residents of the area.

### NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

#### **SECTION 1.**

That all portions of the Property, comprising approximately 4.537 acres of land, are hereby annexed to the City of Fort Worth as a part of the city for all municipal purposes, and the city limits are extended to include such Property being all that certain land particularly described below and depicted as on Exhibit "A" attached to and incorporated in this ordinance for all purposes:

BEING that certain tract of land situated in the J.J. Albirado Survey, Abstract Number 4, City of Fort Worth E.T.J., Tarrant County, Texas, being all of two tracts of land described by deed to Old Granbury Road Holdings, LLC, recorded in Instrument Number D224199629 (Tract 1 and Tract 2), County Records, Tarrant County, Texas, and being more particularly described by metes and bounds as follows:

BEGINNING at the northeast corner of said Tract 2, the northwest corner of Lot 26X, Block A, Chisholm Trail Ranch Phase 1B, an addition to the City of Fort Worth, Texas, by plat recorded in Instrument Number D223213216, and being in the south right-of-way line of McPherson Boulevard, a 110-foot right-of-way recorded in Instrument Number D214206374, both of said County Records;

**THENCE** S 00°37'06"E, 280.39 feet, with the west line of said Lot 26X, to the southeast corner of said Tract 1 and the northeast corner of that tract of land described by deed to Bridget Easton, recorded in in Instrument Number D199054244, said County Records;

THENCE S 89°24'18"W, 704.91 feet, to the southwest corner of said Tract 1 and the east right-of-way line of Old Granbury Road (a variable width right-of-way, no record found);

THENCE N 00°37'06"W, 280.39 feet, with said east right-of-way line, to the northwest corner of said Tract 2 and returning to said south right-of-way line of McPherson Boulevard;

**THENCE** N 89°24'18"E, 704.91 feet, to the **Point of Beginning** and containing 197,650 square feet or 4.537 acres of land more or less.

#### **SECTION 2.**

The above, described territory is shown on Map Exhibit A attached hereto and expressly incorporated herein by reference for the purpose of depicting the location of the hereinabove described territory.

#### **SECTION 3.**

That the above described territory hereby annexed shall be part of the City of Fort Worth, Texas, and the property so added hereby shall bear its pro rata part of the taxes levied by the City of Fort Worth, Texas, and the inhabitants thereof shall be entitled to all of the rights and privileges of all the citizens in accordance with the Municipal Services Agreement and shall be bound by the acts, ordinances, resolutions and regulations of the City of Fort Worth, Texas.

#### **SECTION 4.**

That the Municipal Services Agreement attached hereto as Exhibit "B" is approved and incorporated into this ordinance for all purposes.

### SECTION 5. CUMULATIVE CLAUSE

This ordinance amends every prior ordinance in conflict herewith, but as to all other ordinances or sections of ordinances not in direct conflict, this ordinance shall be, and the same is hereby made cumulative.

#### SECTION 6. SEVERABILITY LAUSE

It is hereby declared to be the intent of the City Council that the sections, paragraphs, sentences, clauses and phrases of this ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the City Council without the incorporation in this ordinance of any unconstitutional phrase, clause, sentence, paragraph or section.

### SECTION 7. SAVING CLAUSE


