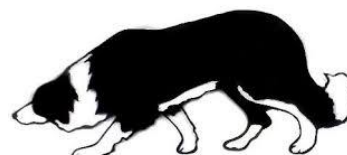

Terms & Conditions of Sale

1. A draw will be made to determine the catalogue order. All dogs to then be sold strictly in catalogue order, being registered, non-registered then pups.
2. All dogs will be sold in pounds and commission to be charged at the rate of 5% (subject to a minimum of £50 per dog) plus VAT.
3. Entry fee per dog is £20 plus VAT (£24) and must accompany the entry form. If withdrawn non-refundable.
4. All dog registration documents are also to be handed to the auctioneers' office on arrival at the sale field (including a signed transfer form), if not carried out the dog will be sold as non-registered.
5. Microchip number MUST be provided, or dogs cannot be entered into the sale.
6. Late entries are accepted on the day of sale and will be sold at the end of the sale on a first come first serve basis.
7. To maintain the integrity of the catalogue there will be NO SUBSTITUTE DOGS. These dogs can be sold on the day as late entries.
8. All dogs are to be shown working on the day of sale; however, the auctioneers give no warranty as to the dog's future ability. Dogs are sold on a non-returnable basis (unless found to be unsold with regards to No. 9 & 10 below).
9. Bitches must be sold as clear of pup unless stated. Bitches purchased in pup and not declared must be accompanied by a vet certificate stating that the bitch was in pup at the time of sale. If the purchaser wishes, they may return the bitch and be reimbursed.
10. All dogs are sold warranted as sound by the vendor on the day of the sale regarding legs, feet, teeth etc. The purchaser of a dog found to be unsound must provide a supporting vet certificate verifying that the dog was unsound at the time of sale. The purchaser has 30 days from the day of sale to lodge complaint with the auctioneers. Dogs found to be unsound may be returned to the vendor and the purchaser reimbursed.
11. Castrated dogs, spayed bitches, or animals with any form of breeding defect MUST be declared at the time of sale.
12. Vendors must not pass dogs to the purchasers without the purchaser providing a receipt of payment.
13. All sales of dogs conducted on the field must be conducted through the auctioneers.
14. No cruelty will be tolerated.
