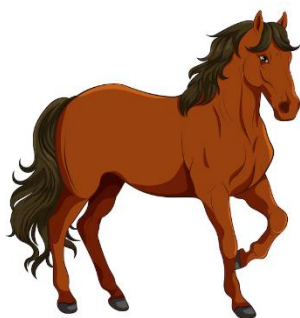

Terms & Conditions of Sale

1. No horse can be sold without a passport, any animals without a passport will not be accepted into the market.
2. All horses will be sold in pounds and commission to be charged at the rate of 5% (subject to a minimum of £50 per horse) plus VAT.
3. Entry fee per horse is £50 which includes VAT (£41.66 P.H. + V.A.T). Entry fee for ponies is £30 which includes VAT (£25 P.H. + V.A.T).
4. All horse passports and any registration documents must be handed into the office pre-sale and will be handed out to buyer once payment is made.
5. All information provided by the vendor is deemed to be correct & the vendor indemnifies the auctioneer against any third-party claims.
6. No substitutions may be made on the day.
7. All horses must be kept on a halter and lead whilst in the mart premises, which means sellers and buyers must have the capability to halter horses.
8. If a mare is in foal, it must be stated on the entry form if a mare comes back to being in foal pre-sale and is not stated buyer is entitled to return the mare to the vendor and a full refund.
9. All horse are sold warranted as sound by the vendor on the day of the sale regarding legs, feet, teeth etc. The purchaser of a horse or pony found to be unsound must provide a supporting vet certificate verifying that the animal was unsound at the time of sale. The purchaser has 30 days from the day of sale to lodge complaint with the auctioneers. Animals found to be unsound may be returned to the vendor and the purchaser reimbursed.
10. Gelded animals must be stated on entry form.
11. Vendors must not pass horses to the purchasers without the purchaser providing a receipt of payment.
12. All sales of horses conducted must go through the ring.
13. No cruelty will be tolerated.

15. By entering a horse in the sale entrants provide consent for name and partial address to be printed in the catalogue and for contact details to be provided at discretion to prospective buyers.
