This conviction has guided me through intersecting paths as a child and adult psychiatrist, child and adult psychoanalyst, and organizational leader. My career has always sought to bridge individual treatment with broader community and societal contexts. Whether leading national associations, editing Echoes of Childhood, directing an institute, or developing humanitarian projects in times of crisis, I have sought to build communities that foster resilience and inclusivity.

These experiences now lead me to seek the president-elect of APsA, where I will bring this listening stance to shaping our collective future. Throughout my career, I have moved between clinical practice, organizational leadership, and community engagement — each strengthening the other. As a child and adult psychiatrist and supervising child and adult analyst, I carry a developmental perspective into my work with patients and trainees. In APsA, as Secretary and Executive Committee Director, I have helped guide our Association through times of challenge and change. As director of a 336-member institute that regularly reaches more than 55,000 colleagues worldwide through its global listsery, I have fostered growth and built pathways for emerging leaders. Through my academic appointments and editorial work, I have advanced scholarship, while internationally, I have led community-based and humanitarian projects recognized by the IPA.

# INTEGRATE TECHNOLOGY WITH CORE PSYCHOANALYTIC VALUES

APsA has a 5-year window to demonstrate to the IPA the effectiveness of online training. This moment calls for leadership that understands both the possibilities and the concerns. I bring deep expertise in teleanalysis, virtual teaching, and hybrid international programming, but my goal is not to advocate uncritically. It is to lead a thoughtful and sophisticated dialogue about how technology can support — and sometimes challenge — our analytic work. As past chair of the International Teleanalysis Clinical Research Group, I will ensure that innovation always remains guided by our core values of connection, accessibility, and analytic integrity.

Technology must serve psychoanalysis, enhancing access while preserving its essence.



## **BRIDGE PSYCHOANALYSIS & SOCIAL CONTEXT**

Psychoanalysis must remain deeply connected to the social environments in which people live. This includes attention to families and communities as well as to issues of diversity and social change. As a child analyst, I have always been implicitly aware of the impact of social context on development and the unconscious. I have recently edited a volume, "Echoes of Childhood: The Foundational Role of Child Analysis in Adult Analytic Work" (in press, 2025) that illustrates how developmental perspectives enrich analytic work with adults. Building on this work, I have developed a four-month virtual book series, beginning in October, where the contributing authors and I will present our chapters in a creative effort to broaden the reach of developmental insights and invite a wider, more diverse audience into the conversation at a modest

Equally central is my commitment to community psychoanalysis, which I have consistently put into practice. In my leadership role chairing the Psychoanalysis in the Community Committee, I have facilitated and led initiatives nationally and internationally that bring psychoanalysis to the front lines of social life. Since February 2022, I have led the International Town Hall Project, APsA's humanitarian response to the fullscale invasion of Ukraine. I am now working with a Ukrainian psychologist to recruit front-line responders for a community-based pilot project, furthering my commitment to linking psychoanalysis with urgent social realities.

By integrating developmental and community perspectives into APsA's curricula, training, and outreach, I will ensure that psychoanalysis remains relevant across the lifespan and responsive to the pressing realities of our time.
