FESTIVAL Rules & Procedures

FOOD TRUCKS: The committee reserves the right to disallow or limit any food directly conflicting with local Main Street restaurants. Food vendors should inform of any space needs, including whether access to electricity is needed. Vendor location will be assigned prior to the event. **Food Vendor Permits must be displayed.** To obtain a permit, please contact the Northeast District Department of Health by visiting, www.nddh.org, or call 860-774-7350 ext 15, M-F, 7 am - 4 pm.

*All food vendors must be approved through the Town of Putnam. Their fees are separate from ours. You can not be at the event if you have not applied and been approved. The paperwork can be found here: https://www.putnamct.us/departments/town-clerk/vendor-permits

Reservations are at the discretion of the committee, based on the number of applicants specializing in the same food items.

WEATHER POLICY: The Fire and Ice Festival Committee strives to ensure that the event moves forward as planned. However, there is a chance that extreme inclement weather may require activities to be cancelled. In the event of heavy rain, a Noreaster, or other unforeseen emergent situations, the committee will consider cancelling the festival. Announcements will be made on WINY Radio 1350AM, as well as on our Discover Putnam Facebook page. In the event that the festival continues despite less-than-ideal weather conditions, vendors who do not show up for the event will not be issued a refund.

SECURITY: You are responsible for the security of your items at all times. Be considerate of your neighbors. Remove trash in your area when you leave.
