Your sacrificial commitment of faith to the work of Jesus Christ at St. Stanislaus Kostka Parish makes this possible.

This stewardship report has been prepared by our bookkeeper, Joann Stainko and myself, and has been reviewed by our Finance Council and Pastoral Council. We have expanded its format in hopes of providing an even clearer and more thorough accounting of all aspects of the finances of our Parish.

Looking forward we are almost done with our most necessary repairs to our parish facilities. Looking ahead to the fiscal year of 2023-2024 we need to put on a new roof and commercial gutters for the parish office building, fix the sidewalks, continue to refurbish the parish hall, and continue to address our facility priority list created two years ago.

As the spiritual father and chief steward of this great household of faith, I take with utmost seriousness my obligation to render a full account both to the Lord and to you of our shared stewardship of His gifts. It is my hope that this report will also serve us moving forward. With all my heart — and on behalf of the countless people who benefit from your sacrifices in innumerable ways — thank you for continuing to expand the sharing of your gifts!

Campus Improvements during the 2022/2023 Fiscal Year

Church: The source and summit of our Catholic Faith is the presence of Jesus Christ with us in the Holy Eucharist. Thus, it was essential to address much needed investments with the repair of the apse and choir loft stained glass windows, the sanctuary electrical outlet updates, sump pump, professional carpet cleaning, flat roof repair, and 4 new LED lights installed in the narthex. Total investment: \$24,583.00

Parish Pastoral Office/Religious Education Building: A welcoming environment for visitors and a more efficient workspace was needed. After significant improvements were made in 2020/2021, additional improvements are needed for the future. This includes a new roof and commercial grade gutters, an HVAC unit for heating and air-conditioning upgrade, new windows, and new carpet. Total investment: \$1,493.00

Parish Rectory: The house that the priest of the parish lives in is over 100 years old and is in need of refurbishment. This includes painting, drywall/plaster repair, flooring and kitchen upgrades. Improvements included drywall/plaster repair in the upstairs of the house and flooring restored. Improvements still needed include: 1st floor flooring and ceiling repair, basement flooring repair, kitchen upgrade and repair, and deck repair. Total investment: \$5,264.72

Parish Grounds: We pay a company for our snow removal and mowing. At the start of the new fiscal year for 2022-2023 we repaired and restriped the Church parking lot. Additionally, we cleaned out the sceptic tank which had not been done since 2015. The grotto was also maintained and gutters cleaned out. In order to improve the beauty of our vast grounds, several improvements and repairs will be necessary in the future. These include, the removal of several more trees and the repair of the sidewalks and curbs. Total investment: \$25,026.00

Parish Hall: Improvements to this building included the installation of a new roof, commercial grade gutters, and the kitchen flooring deep cleaned and waxed after more than 15 years of not being done. The kitchen walls, ceiling, and cabinets were cleaned and painted, and additional LED lighting was installed in all closets and storage rooms. Painting of storage rooms and the masonry repair work of the venting chimney. Additionally 2 new HVAC systems installed and 2 others repaired. Additional work needed for the future includes new painted hallways and ceilings, new windows, main hall flooring restoration and repair, and LED lighting installed in the outside of the building. Total investment: \$92,884.90

Our parish was able to operate with a surplus of income over expenses for the 2022-2023 fiscal year. Offertory collections, which represent 51% of church income, decreased by 4% over the prior year. Overall, church income increased 7% over the prior year and was 9% above the budgeted amount. Additionally, donations and bequest were up by 51% of the budgeted amount, with the help of the generous grant of \$25,000.00 from the Mary Cross Tippmann Foundation. Facilities expenses increased due to many repairs and upgrades especially with the addition of a new parish hall roof and commercial grade gutters, parish hall kitchen painting and flooring repair, and the parking lot resurfaced. (Look on the previous page for a more detailed breakdown.) Total costs of this work was \$167,651.62. Our rental event income decreased slightly from the previous year. But we must remain vigilant as costs have risen significantly in the last three years. We look to save expenses additionally, as we now have only part time employees, which is reflected in the direct payroll, taxes, and benefits.

The diocesan quota is for the administrative cost and services provided to St. Stanislaus Kostka Parish by the diocese. It is based on a formula that weighs Sunday collections. Our cash balance at June 30, 2023 represents 150 days of operations. Optimal cash balance should cover 180 days of operations as emergences and inconsistent contributions can erode the balance.

Looking forward, we have planned a balanced budget for the 2023/2024 fiscal year and are confident it can be achieved for another year. Any increase of income above our budget amounts will be a substantial growth toward greater financial stability for our parish. We will use this increase to address our deferred maintenance items, address our facilities, and to build our cash reserve.
