

Dear Brothers and Sisters:

The Pilgrimage for Youth Board of Directors have announced the 2026 tour dates and cost. The tour will take place July 17 - July 30, 2026, and will begin and end in Philadelphia. The cost is \$2,100 per student, plus the cost of airfare and a baggage fee to be determined later.

Rebekah Assembly Past President Terry Adams has been named Jurisdictional Chairperson for Texas for the 2026 tour. I'm sure she will have some great ideas for your lodge on fundraising as well as finding deserving students to participate in the tour. Please contact her at terrydadams02@gmail.com for assistance.

If your lodge has never sponsored a delegate, I hope you will consider doing so. If your lodge can't afford the cost of a delegate sponsorship on your own, then please consider sponsoring a delegate in conjunction with another lodge or with all lodges within your district. If you don't personally know a young person who would be eligible for the trip, please consider speaking with the Guidance Counselor at your local High School. I'm sure they will be familiar with deserving students who will exhibit the type of conduct desirable for those chosen as delegates. Be sure to mention that the tour provides a scholarship opportunity through a speech contest.

The delegate fee of \$2,100.00 is due on January 26, 2026, and no refunds will be offered. The delegate application is also due on January 26, 2026. The fees and applications should be forwarded to the Grand Lodge I.O.O.F. of Texas, 3440 W. Second Avenue, Corsicana, TX 75110.

The tour is open to students who are 16 and 17, who are Sophomores or Juniors in High School. Students who reach the age of 18 prior to the summer program are not eligible to participate. Delegates must have at least one year remaining in High School after the Tour.

Some important highlights:

- Passports and out of country insurance will not be required for the 2025 tour.
- All delegates are required to have a current medical examination prior to the Tour.
 The physical cannot be done prior to January 1, 2026.
- All delegates must start the tour on the beginning date and stay with the tour until its end date.

- Deadlines are important and must be met to allow for efficient coordination of the Tour.
 The Sovereign Grand Lodge Office charges a late fee of \$50 per delegate for missing deadlines.
- All delegates are required to participate in the speech contest in New York.

Enclosed is the 2026 delegate application form along with general information for the delegate. Please make copies of these forms as required.

Please remember the following deadline:

January 26, 2026 - The \$2,100 non-refundable delegate fee is due along with the completed delegate application. You will be billed for the cost of airfare at a later date.

For additional information, please check out the web site at www.ioofpilgrimageforyouth.com. The deadlines shown on the web site may be different from the deadlines listed above. This is because we must have time to collect the payments and forms from the sponsors and then forward everything to the Sovereign Grand Lodge Office by the deadlines listed on the web site.

Dear Brothers and Sisters:

The closing of the I.O.O.F. Event Center has created a situation with the meeting location for the Rebekah Assembly Session whose Constitution mandates that they shall meet at the same place the Grand Lodge I.O.O.F. of Texas shall hold its annual session. With the Event Center being unavailable, the Rebekah Assembly of Texas has no place in which to hold their session.

To accommodate both units, the General Arrangements Committee has devised a plan whereby both units will share the B. J. and Jerry Miller Conference Room located in the Grand Lodge Administration Building in Corsicana, Texas. This will result in some changes needed for the Grand Lodge Session schedule and therefore a Special Session will be needed to address them. Please refer to the attached Resolution for more details about the proposal.

In accordance with Chapter II, Article IV. Sec. 4, Clause 1 of the Constitution of the Grand Lodge I.O.O.F. of Texas, the Grand Lodge Executive Committee has authorized a special session of the Grand Lodge I.O.O.F. of Texas to be held Saturday, November 15, 2025. The session will begin at 10:00 A.M. in the B. J. and Jerry Miller Conference Room located in the Grand Lodge Administration Building in Corsicana, Texas.

Outlined below is the purpose of the Special Session and the only matter of business to be conducted:

 Consider and vote on the enclosed Resolution No. 1 regarding the 2026 Sessions of the Grand Lodge and Rebekah Assembly of Texas.

Everyone attending will need to check in with the Credentials Committee beginning at 9:00 A.M. The Grand Lodge Degree will be conferred at 9:30 A.M. If you would like to receive the Grand Lodge Degree, be sure to bring a Past Grand or Past Noble Grand Certificate from your lodge indicating your eligibility.

Only Past Grands and Past Noble Grands, who have attained the Third Degree, have membership in an Odd Fellow Lodge in good standing, and have received the Grand Lodge Degree, will be allowed to vote in the session. Third Degree members of an Odd Fellow Lodge who have not received a Past Grand or Past Noble Grand ranking will be allowed to enter the session; but are not eligible to vote.

I encourage everyone to attend the Special Session on November 15, 2025 in order for us to move forward in planning for the March 2026 Sessions.
