<b>Notes</b>	<p>The nurseries have an on-site cook who prepare nutritious, balanced meals each day, following the <a href="#">Early Years Foundation Stage Nutrition Guidance (May 2025)</a>. Our menus are thoughtfully planned to support children's growth, development, and healthy eating habits, offering a wide variety of fresh ingredients and seasonal options. We use locally sourced produce wherever possible, including fruit, vegetables, dairy, and meat supplied by a trusted local butcher.</p> <p>All nursery staff hold Food Hygiene Level 2 certification and have completed allergy and food-intolerance awareness training. This ensures that food is prepared, handled, and served safely and that children with allergies or dietary restrictions are fully supported. We operate a strict allergen management procedure, including clear labelling, separate preparation areas where required, and individualised plans for children with specific needs.</p> <p>We strive to accommodate all children's dietary, cultural, and religious requirements, providing suitable alternatives where necessary. Vegetarian, vegan, halal, and other specialised meals can be offered upon request, and parents are encouraged to discuss their child's individual needs with the nursery manager.</p> <p>Meals are served in a calm and sociable environment that encourages children to develop independence, make healthy choices, and enjoy positive mealtime experiences. <p><b>Suncream &amp; Wipes:</b> Suncream is applied as needed to ensure children are protected during outdoor play. <b>Wipes</b> are used for <b>hygiene purposes</b> throughout the day, and all products are chosen with sensitivity and skin safety in mind.</p> <p><b>Paediatric First Aid Training (Millie’s Mark Accreditation):</b> All staff are trained in <b>Paediatric First Aid</b>, and the nursery proudly holds <b>Millie’s Mark Accreditation</b>, demonstrating our commitment to the highest standards of safety and emergency preparedness.</p> <p><b>Outdoor Clothing:</b> To support daily outdoor learning in all weather, children are provided with appropriate clothing such as <b>waterproof trousers, jackets, and wellies</b>. This ensures they can safely explore and enjoy outdoor experiences year-round.</p> <p><b>Ad Hoc Specialist Trips and Activities:</b> Children regularly take part in enriching activities, including <b>local walks, community visits, and specialist trips</b>. <p><b>Government Funding and Additional Charges</b> - Government funding is not intended to cover the cost of meals, consumables, additional hours, or additional services. As a result, charges will apply for items and provisions that fall outside the funded entitlement.</p> <p>Providing a high-quality Early Years Foundation Stage (EYFS) environment requires resources and staffing beyond the minimum statutory requirements. This includes high-quality care and education, a nutritious and well-balanced diet, enhanced learning resources, stimulating activities, and ongoing staff training that exceeds standard statutory expectations. These elements ensure children receive the best possible early years’ experience.</p>
