Schedule of IT partners

- **One-Touch IT (OTIT)** – is the firm's IT management partner and provide operational IT support. This support includes, but is not limited to:
 - assisting with our IT planning – including internet management, website domain name management
 - managing our IT structure – including our MSO online server and our Microsoft licencing
 - managing our IT assets
 - our cyber security maintenance
