- HUD CoC Funding Request Submitted February 9th, attached
  - The FY26 NOFO will be released before 6/1/2026 with awards before 12/1/2026.
  - THANK YOU to everyone who contacted their congressional representatives to advocate over the last few months, our collective voice holds weight!

- VHSP is anticipated to be a non-competitive renewal for FY27, Federal RRH portion of current VHSP grants will be available soon, with grant agreements coming shortly from DHCD. Expenditures for federal funds will be given 12 months beginning on the execution date of the grant agreement.
