### PROFESSIONAL SERVICES OF FUNERAL DIRECTOR AND STAFF

**Basic Services of Funeral Director and Staff** **\$995.00**

*“This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving of remains).”*

Our services include, but are not limited to, staff to respond to initial request for service; arrangement conference with family or responsible party; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notices; staff assistance prior to, during and following the funeral, including coordination with those providing other portions of the funeral, e.g. cemetery, crematory, and others. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory costs.

## **EMBALMING**

*“Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.”*

## **FUNERAL HOME FACILITIES AND EQUIPMENT**

### **Facilities and Staff for Visitation and Viewing** **\$425.00**

Our charges include use of facilities and staff services for visitation (per day), set-up of visitation area, placement of encased remains, display of floral arrangements, supervision of and attendance during the visitation.

### **Facilities and Staff for Funeral Ceremony** **\$425.00**

Our charges include use of facilities and staff services for funeral service, coordinating the funeral arrangements, supervision of funeral, and staff to attend the funeral service.

### **Facilities and Staff for Memorial Service** **\$425.00**

Our charges include use of facilities and staff services for memorial service (without body), coordinating the memorial service arrangements, supervision of the memorial service and staff to attend the service.

### **Equipment and Staff for Visitation at home or church** **\$425.00**

Our charges include use of necessary equipment and staff for ceremony at outside facility, coordinating the funeral service arrangements, supervision of the services and staff to attend the funeral service.

### **Equipment and Staff for Graveside Service** **\$225.00**

Our charges include accompaniment of remains to cemetery, supervision of graveside service and staff to attend the service.

### **Grave Equipment Set-up** **\$300.00**

Our charges include use of lowering device, artificial grass, chairs and personnel to set up the equipment.

Our charges include use of artificial grass, chairs, table and personnel to set up the equipment.

**Transfer of Remains to Funeral Establishment** **\$300.00**

The containers we provide are made of corrugated cardboard."*
