VI. Approval of Previous Meeting Minutes

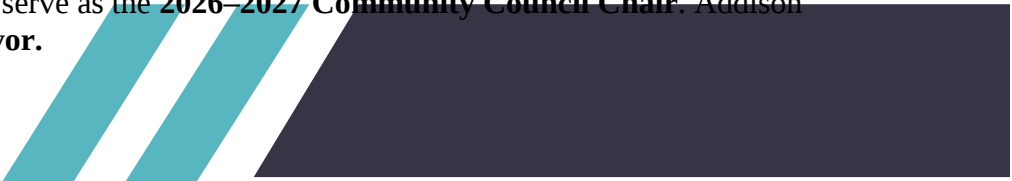
The minutes from the previous meeting were presented for approval.
