

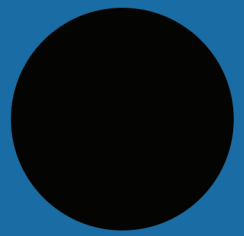

# 2026 NLN SUMMIT EXHIBITION TERMS AND CONDITIONS

The NLN reserves the right to accept or refuse a booth application from any exhibitor, and, once the exhibit is on the floor, to require its modification or removal, whenever the NLN considers such an exhibit to be detrimental to the NLN's business, professional, or ethical interests; if the displayed products do not meet the professional standards of the NLN; or the exhibit does not comply with the rules and regulations for exhibiting at the Education Summit.

Exhibitors agree to display products or services in a tasteful, informative, and educational manner. The NLN, in its sole judgment, reserves the right to prohibit any exhibitor from displaying or advertising any products or services that are considered offensive or that violate NLN rules. Exhibitors who demonstrate aggressive sales tactics (i.e., yelling at attendees, standing in aisles and physically pulling attendees into their booth) will be removed from the hall and forfeit their registration fees.

Exhibitors further recognize and agree that NLN retains full power and authority to interpret and enforce all rules and regulations for the NLN Education Summit, including the authority to amend or adopt new rules and regulations that NLN considers necessary and proper for the event. If an exhibitor is asked to leave the exhibit hall due to an infraction as noted above, it is agreed that no refund shall be made by the National League for Nursing and no demand for redress will be made by the exhibiting organization.

All exhibits must be freestanding and self-supporting and may not obstruct the view of, or interfere with, any adjacent booths (line-of-sight rule). No part of an exhibit or sign may be pasted, nailed, or otherwise affixed to walls, doors, etc. Exposed, unfinished sides of an exhibit booth must be draped. *The subletting or sharing of space is prohibited; two or more firms may not exhibit in a single space without prior approval from the NLN.*

An exhibitor kit containing literature and rates for all labor services, furniture rentals, electrical connections, internet, and other miscellaneous services is made available by the exhibit show decorator, Freeman, and is sent to all exhibitors after exhibit space assignment is confirmed and paid in full.

All furnishings, carpet, and special arrangements must be made through the exhibit show decorator. The following services are not included as part of the booth fee: tables, chairs, other furnishings, carpeting, drayage/shipping, set-up/break down labor.

The official service decorator provides freight handling services. Exhibit material, packages, and/or shipments cannot be received at the hotel unless deliveries are made on move-in days. Otherwise, deliveries will be returned to the shipper at the exhibiting company's expense. Please refer to the shipping instructions in the contractor's service kit.

Exhibit material left in the hall after the posted move-out time, or damaged exhibits left behind, will be removed by the official service contractor at the expense of the individual exhibiting company. Any materials remaining after the departure of the show decorator is considered abandoned.

By submitting a registration, the exhibitor assumes the entire responsibility and liability for losses, damages, and claims arising out of exhibitor's activities on the Hotel premises and will indemnify, defend, and hold harmless the NLN, the Hotel, its owner, and its management company, as well as their respective agents, servants, and employees from any and all such losses, damages, and claims. The National League for Nursing does not endorse or promote any products or services related to an exhibit, and exhibitors cannot suggest otherwise without prior written approval from the NLN.

## REGISTRATION & CANCELLATION

A booth and/or sponsorship reservation is not complete unless full payment has been received by the stated deadline. Credit card payments are due at the time of reservation. Check payments are due within 30 days of invoice receipt. All payments must be received by **August 27, 2026**.

If payment is not received by the deadline, exhibitor/sponsor may forfeit their reservation.

Written cancellations of **booth** space will be accepted through August 27, 2026, and refunds granted minus a \$250 cancellation fee. ***Without exception, booth refunds will not be granted after August 27, 2026.***

***Sponsorship reservations are not eligible for a refund at any time.***

The NLN reserves the right to modify, cancel, or postpone any or all Summit activities. In the event the NLN is required to adapt the Summit program to a virtual format, the NLN will automatically transfer existing registrations to the new format and issue a refund for any difference in price. In the event the Summit must be cancelled in its entirety (both in-person and virtual), registration fees will be refunded in full. All other cancellations are subject to the policy as stated above.

Participation in the NLN Education Summit constitutes an agreement by the registrant/booth staff to allow the National League for Nursing to use and distribute the registrant's and or booth's photographic image on the NLN Web site, in promotional materials (e.g., e-mails), and in NLN periodicals and newsletters. Additionally, registering as an exhibitor or sponsor grants the NLN permission to use exhibitor/sponsor's name and logo within both print and digital directories associated with the conference. By submitting a booth registration, all exhibit staff agree to comply with health and safety measures as identified by the World Health Organization (WHO), Centers for Disease Control (CDC), NLN, and Washington Hilton to promote and maintain a safe conference experience. Specific requirements will be communicated prior to the start of the Summit.

If a potential state institution exhibitor is subject to any state laws that may be contrary to any of the 2026 Summit terms and conditions, the NLN will make good faith efforts to work with the state institution to seek a resolution that meets the needs of both parties.
