When I promised Stan I would put together a bio for the newsletter, it seemed like a relatively easy thing to commit to; how hard can it be to summarize roughly 40 of my 65 years in a few paragraphs. Actually, it turned out to be much tougher than I imagined. But a promise to a brother is a promise that has to be kept. So, here we go.

After graduating from UMass in 1970 and doing my obligatory 6 months on active duty with the Indiana National Guard (a whole other story), I settled down in the New York area. Career wise, I spent the next 30 years in corporate America, twenty-five of them with Prudential Financial in Newark, NJ. When I retired from Prudential in 2000, I was senior vice president and controller of the Company.

I ve done a number of things in my post-Prudential careers. I ran a non-profit that assisted disabled veterans become successful entrepreneurs, was the CFO of the Country s fourth largest public school district, started and sold my own technology company, and have done a little consulting. Today, I m working with a friend on another start up and serve on the Boards of Directors of two manufacturing companies. So I stay busy and mostly out of trouble. (The exception being when I visit Goldfarb in Las Vegas.) All told, its been a rewarding professional life made possible by a UMass education that was augmented in large measure by watching Jeopardy at noon with Fortier, Grzenda and others in the old house in lieu of mid-day classes.

Most importantly, in 1971 I met Diane Rosendahl, and in a serious lapse of judgment she agreed to marry me in 1972. We have three children. Adam, now 34, is a portfolio manager with a major financial institution and lives in New Jersey with his wife and my two granddaughters; Jeremy, now 30, is a lawyer and consultant specializing in communications and broadband issues and lives in DC; and Sara, now 27, is a marketing manager, also lives in DC.

As many of you know, Diane had major health issues, and spent the last nine years of her life in a wheelchair. It was her health that necessitated a move to Florida in 2004, as we needed to get her out of winter permanently. As you may also know, she passed away in 2013 after a long and gallant fight with cancer and its aftermath. It was tough to deal with, but the support of my biological family and my fraternal one was instrumental in getting me through the roughest days. I can t say enough about how much the Phi Sig brothers did for me.

I moved back to New Jersey this fall to be closer to my kids and grandkids. That s correct, I left Florida for New Jersey right before the worst winter in years. Maybe I should have skipped Jeopardy and gone to class more! But I live three blocks from my granddaughters and see them often, absolutely the best medicine.
