However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy certain items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Basic Services of the Funeral Director & Staff \$395.00

Our basic service charge includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family or responsible party; preparation and filing of necessary certificates and permits; shelter of remains; placement of obituary notices; planning of funeral arrangements; and coordination of service with cemetery, crematory, vault companies and others as required. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, equipment and inventory expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for Direct Cremation, Immediate Burial and Forwarding of or Receiving Remains.)

Disposition of human remains by cremation, without formal viewing, visitation or ceremony with the body present. This charge includes basic services of funeral director and staff, local removal, the cremation process charge, temporary container for the cremated remains, and the county cremation permit. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is made of cardboard.
