If you do prefer a sealed casket, you should never pay more than \$50–\$100 extra. Don't be pressured into spending hundreds more on a feature that offers no real advantage.

Under federal law, funeral homes must accept caskets purchased from outside vendors at no additional cost. The **FTC Funeral Rule** protects this right, and violations can result in fines exceeding \$53,000 per infraction.

High-quality 18-gauge metal models, typically priced around \$1,500, can even be shipped overnight directly to your chosen funeral home.
