## EDUCATION REQUIREMENTS ACKNOWLEDGEMENT

**Membership Requirements:** I acknowledge that active membership is contingent upon completing four mandatory education courses within the required timeframes. This includes two in-person sessions at the RSCK Office (170 W. Dewey St., Wichita, KS) and two online courses. **While access to Association and MLS services is granted upon payment of dues, failure to complete these educational requirements will result in membership suspension and applicable reinstatement fees.**

- **New Member Orientation:** Shall be completed within ninety (90) calendar days from the date of joining.  
*\*Members residing 45+ miles from the RSCK office are eligible for virtual participation.*
- **"ELITE 1" Laws Class:** Shall be completed within six months or (180) calendar days from the date of joining.  
*\*Exemption from this course is available to Brokers, as well as applicants who have held RSCK membership within the previous 2-year period. Other licensed professionals may also qualify for a waiver depending on licensing history and specific criteria. In-person attendance required.*
- **Online: NAR Code of Ethics:** Shall be completed within ninety (90) calendar days from the date of joining.
- **Online: NAR Fair Housing "FairHaven 2.0":** Shall be completed within ninety (90) calendar days from the date of joining.

**Secondary RSCK Members Only:** *I hereby certify my understanding that New Member Orientation is the sole educational requirement for Secondary Membership with RSCK. I agree to complete this requirement within ninety (90) calendar days from the date of joining; all other new member education requirements are waived for secondary status.*

All correspondence and notifications pertaining to these educational requirements, including registration, deadlines, course availability, and completion status, will be primarily communicated through email. Upon completion, members will be transitioned from a Provisional Member to a REALTOR®.

Written exceptions to these requirements must be approved by the RSCK Membership Specialist and/or RSCK CEO under qualifying circumstances.

## FINAL PROVISIONS

I acknowledge that if accepted as a Member and subsequently resign or am expelled from membership in the Board with an ethics complaint or arbitration request pending, the Board of Directors may condition renewal of membership upon verification that I will submit to the pending ethics or arbitration proceeding and will abide by the decision of the Hearing Panel. If I resign or otherwise cause my membership to terminate, the duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided the dispute arose while applicant was a REALTOR®.

I hereby certify the foregoing information furnished by me is true and correct, and I agree that failure to provide complete and accurate information as requested, or any misstatement of fact, may be grounds for revocation if my membership, if granted.
