As required by State of Ohio Regulations, Bee Driving School will make all training available, based upon attendance at all training sessions offered and fee paid in full, to the student by \_\_\_\_\_.

Bee Driving School shall furnish a licensed instructor and a motor vehicle for instruction. Instructions for the classroom and behind the wheel are based upon the Ohio Driver's Training curriculum. We do not guarantee the issuance of a driver's license to the student. Students, under 18 years of age, who successfully complete the course, will receive a Certificate of Completion. If a replacement certificate is required, there will be a charge of \$15.00.

Students may begin the classroom instruction at age 15 years and 5 months, before obtaining a temporary driving permit. However, the student is required to obtain a valid temporary driving permit and pay tuition in full prior to scheduling the practical driving portion of the training. Failure of the student to appear or cancel a scheduled driving appointment before a minimum of twenty-four (24) hours prior to the scheduled appointment shall be charged as a lesson at an additional fee of \$25 per hour. If student does not complete course, a refund may be pro-rated, based upon hours of service provided prior to cancellation. No refunds will be made after six months of this dated training agreement. Should a check received as payment of tuition in whole or in part, be returned due to insufficient funds, the Student may be removed from driving schedule until such check is made good. An additional fee may be charged for any returned check.

Bee Driving School reserves the right to cancel this agreement at any time, should the Student's conduct indicate a lack of responsibility deemed necessary by Bee Driving School to safely operate a motor vehicle. Destruction of property, or the possession, distribution, or use of any tobacco product, alcohol, or drug of abuse is strictly prohibited. Should this agreement be cancelled under such circumstances, all fees may be pro-rated, based upon hours of services provided prior to cancellation.
