Increase Advance Care Planning (ACP) Knowledge in General Practice

First steps

Goal What are we trying to accomplish? By when?

Example 1: Increase practice staff knowledge of Advance Care Planning, skills, and confidence with ACP conversations by ## (date).

Measures How will the change be measured?

Example 1: Survey results. Record baseline survey data of practice staff rating knowledge, skills, & confidence levels. Prediction: Improvement in practice staff self-rated knowledge and skills in ACP.

Improvement ideas

- Increase practice staff knowledge, skills, and confidence with ACP conversations
- Develop, distribute & collect staff survey to gather baseline data of existing practice staff knowledge, skills, and confidence with Advance Care Planning

- Distribute & collect follow up staff survey assessing ACP knowledge, skills and confidence with Advance Care Planning

Ideas for further PDSA cycles:

How?

Utilise a Plan-Do-Study-Act (PDSA) cycle, a useful tool for documenting change.

The cycle's steps are: Develop a plan to test the change (Plan), carry out the test (Do), observe and learn from the consequences (Study), and determine what modifications should be made to the change (Act).

Practices can undertake several PDSA (cycles) for **continuous improvement** until you've achieved the goal or move to a different goal.

Use the editable worksheet template (page 3) to document each change you attempt and store the completed documents together.
