Manage the distribution of one-off grants between \$25,000 to \$50,000 (based on general practice size) enabling to support investments in innovation, training, equipment, and minor capital works in one or more of the following three investment streams:

1. 1. enhance digital health capability – to fast-track the benefits of a more connected healthcare system in readiness to meet

future standards;

- 2. 2. upgrade infection prevention and control arrangements to ensure infectious respiratory disease (e.g. COVID, influenza) patients can be safely seen face to face; and/or
- 3. 3. maintain and/or achieve accreditation against the Royal Australian College of General Practitioners Standards for General Practice, under the General Practice Accreditation Scheme to promote quality and safety in general practice.

SEMPHN teams across PACSIPACSI's /Provider Support, Contracts, Finance and Strategic Relations will plan and deliver a robust efficient grants process.

A eperson will be recruited to Business Services to ensure efficient processing of grant applications, contracts and funds. Clear communication to practices of grant funding and eligibility will occur to provide clarity and temper expectations. Communications will be released during April/May 2023 regarding the availability of grants, the process and criteria for applying.

Provider Support Officers (PSOs) will utilise CRM and their knowledge to cross check practice grant applications and federal government practice size tiering (which will be supplied to SEMPHN).

Grant applications will be processed and administered using utilising SEMPHN's contract, invoice, risk, compliance and audit software Folio to track and administer.

A person will be recruited to administer the processing of grant applications, contracts and funds.

The 1.0 FTE Program Lead utilises the needs assessment and literature review to inform the final planning, development and delivery of activities to coordinate improved access to palliative care services at home.

During 2023-2024 projects will be implemented to:

- Improve communication between General Practice and Community Palliative care services by embedding referrals into the common PalCare software platform.
- Increase knowledge and use of Advance Care Planning through education, online information, and a pilot ACP model of care in general practice in collaboration with the local hospital ACP service.
- Improve access to palliative care medications for people in the community by implementing a Core Medicines List across general practice and pharmacy that includes an online resource map.

SEMPHN is assisting PwC with their Australia wide evaluation that will include quantitative and qualitative data collection and outcome measurements, including baseline data where available.

To address physical impact of elders living in Residential Aged Care Facilities (RACFs) affected by outbreaks of COVID-19. Activity has been extended to 30 June 2023 to expend remaining funds.

Description of Activity *

Structured physical group therapy for eligible Elders living in impacted RACFs delivered by appropriately qualified allied health staff. Due to extended RACF lockdowns during COVID-19 outbreaks, extensions into 2021-2022 were approved with a carry forward of \$2,547,330.00. The allied health provider as well as the RACFs reported successes as evidenced in a number of case studies completed throughout duration of program. Third round of activity to be complete 30 June 2023 will expend all funds. Feedback received was positive and indicated the activity was well-timed in its support of those most impacted by lockdowns.
