UCO PROCUREMENT AGREEMENT

THIS AGREEMENT is entered into on ____ day of _____, 2025 (the "Effective Date"), between Z Energy Solutions, LLC, ("Buyer") and _____, located at _____ (address) (the "Seller").

RECITALS

Buyer is in the business of refining Used Cooking Oil ("UCO") for the production of biodiesel fuel; Seller is (i) in the business of collecting UCO and/or purchasing UCO from other individuals or companies who collect or purchase UCO and (ii) selling such UCO to third parties, including the Buyer;

Tracking of UCO Data:

- Buyer desires to continue purchasing UCO from you. In order to do so, Buyer needs your agreement that you will maintain the necessary records required to show the following:
 - Point of Origin of Data
 - UCO volumes collected and rendered

Cooperation with Third party Verifier and CARB or ORDEQ

The California Air Resources Board (CARB) has implemented changes in the Low Carbon Fuels Standard (LCFS) that directly impact UCO as a feedstock for fuels in California.

- Buyer may receive an annual verification and may be required to provide data about its suppliers, including the volume of UCO it purchased from you as a supplier.
- For the annual verification, a third- party independent verification company, which will enter into a non-disclosure agreement with your company, will verify the data that Buyer has supplied to them.
- Please be advised the verifier may need to visit your facility to confirm any transactions between your company and Buyer. Your cooperation with the verifier would be greatly appreciated.

Only the verification company and CARB/ORDEQ see this data and they are subject to the NDA.

By your signature below, you agree to cooperate with the third-party verifier by providing requested information regarding sales of UCO to Buyer and, if necessary, cooperate with the third-party auditor in an on-site visit.
