A MESSAGE FROM OUR MINISTER

"Finding Inspiration Through Humility: The Power of Surrendering to the Holy Spirit"

In our journey of faith, we often find ourselves facing moments that demand profound wisdom or inspiration. Whether it's writing an Annual Report, preparing a sermon, or simply seeking direction in our daily lives, the pressure to produce something meaningful can be overwhelming. It's in these moments that we often discover a profound truth: our greatest breakthroughs come not from our own striving, but from a place of humble surrender.

Picture yourself in a car, wheels spinning frantically, axle-deep in mud. The more you press on the gas, the deeper you sink. This imagery vividly illustrates our human tendency to rely on our own efforts when faced with challenges. We push harder, we strain more, yet we find ourselves increasingly stuck. It's a frustrating and exhausting cycle that many of us know all too well.

But there's a beautiful turning point that occurs when we finally exhaust our own resources. It's in that moment of acknowledging our limitations that we open ourselves to something greater. As we cease our frantic efforts and quiet our minds, we create space for the Holy Spirit to work within us. This is where true inspiration begins to flow.

The apostle James captures this principle perfectly in his letter: "God opposes the proud but gives grace to the humble" (James 4:6). This verse isn't just a pithy saying; it's a profound truth that can transform our approach to life and ministry. When we humble ourselves, admitting that the task before us is beyond our capabilities, we position ourselves to receive God's grace and guidance.

This principle doesn't just apply to individual struggles. In fact, it's the cornerstone of vibrant, Spirit-led community life. What I love most about Grace, is that I've experienced a church filled with humble saints, each quietly allowing the Holy Spirit to guide them into various forms of ministry. It's a beautiful tapestry of service, woven together by individuals who recognize that their contributions, however small they may seem, are vital parts of God's greater plan.

We are a community; you'll find us engaged in a myriad of meaningful activities:

- Listeners who create safe spaces for others to share their stories
- · Faithful prayer warriors interceding for families in need
- · Committee members working diligently behind the scenes
- Teachers pouring into the lives of children
- · Volunteers reaching out to the homebound and isolated

These acts of service, and a million more, done with a humble heart, become a powerful conduit for God's love and grace. It's in this collective humility that the body of Christ truly comes alive, with each member playing their unique and essential role.

This approach to ministry and life stands in stark contrast to the world's emphasis on individual achievement and self-promotion. Instead of striving to be seen as the source of wisdom or strength, the beauty of this approach is that it relieves us of the crushing pressure to always have the right answers or to constantly produce profound insights. Instead, we can rest in the knowledge that God is the source of all wisdom and that He delights in working through humble, willing vessels.

As we embrace this humble posture, we find that inspiration comes in unexpected ways and at unexpected times. A casual conversation might spark a profound realization. A quiet moment of reflection could unveil a solution to a long-standing problem. Even in our moments of doubt or struggle, we may find that God is using these experiences to shape us and prepare us for future ministry.

Moreover, this approach to life and ministry is contagious. As others witness the peace and effectiveness that come from surrendering to God's guidance, they too are inspired to adopt a posture of humility. This creates a beautiful cycle of grace, where the entire community grows in its dependence on, and responsiveness to, the Holy Spirit.

As we embrace this way of living and serving, we'll likely find that the "mud" that once held us back becomes the very ground from which new life and ministry spring forth. Our moments of stuckness transform into opportunities for God's power to be displayed.

In the year ahead, let us remember that our greatest strength lies not in our own abilities, but in our willingness to humble ourselves before God. As we do so, we open ourselves to a wellspring of divine inspiration and grace that can transform not only our own lives but the lives of those around us. May we continually seek to be a community marked by humility, responsiveness to the Holy Spirit, and a collective commitment to allowing God's love to flow through us in countless, beautiful ways.

- 2. Opening Prayer: Rev. Glen Wells
- 3. In-Memoriam Reading by Rev. Glen Wells from the 2023 Annual Report.
- 4. - 6. <u>Motion</u> to approve the Agenda as circulated. Moved by Bill Imeson, seconded by Keith Crawley. **Carried.**
- 7. <u>Motion</u> to approve the Annual Meeting Minutes of February 26, 2023 as printed. Moved by Bev Layden, seconded by Roy Shipton. **Carried.**
- 8. <u>Motion</u> to approve the Minutes of the Congregational Meeting on January 14, 2024 as printed. Moved by Lynne Shipton, seconded by Donna Tansley. **Carried.**
- 9. Business Arising from the Minutes: James McMillan reported that Food4Kids Brant-Haldimand did not restore their charitable status and our funds were transferred to Food4Kids Hamilton as per last year's motion. This is part of the Local Missions giving.
- Motion to accept the 2023 Statistics. Moved by Marg Crawley, seconded by Diana Prince.
 Carried.
- 11. Financial Reports:
 - a. <u>Motion</u> to accept the 2023 Certification report completed by Wayne and Janice Lanigan.
 Moved by Bill Imeson, seconded by Paul Mitrovich. Carried.
 Bill Imeson reported Wayne and Janice Lanigan have passed on their gratitude to the
 Church Congregation and the Treasurer for having such clear records. It was a pleasure
 for them to review the records.
 - b. <u>Motion</u> to accept the Operating Fund Reports: Moved by James McMillan, seconded by Leigh-Anne Unrau. **Carried.**
 - James McMillan explained that page 14 of the annual report is one of the consolidated statements showing the total financial assets (excluding the real estate) of the church that is filed annually with the Canada Revenue Agency. In the eyes of the government and the national church, all of the groups at Grace are a single unified organization, and as such he has to consolidate all the finances each year and be reasonably sure everything matches up as he signs to guarantee their accuracy.

On the operating side, the church did very well this year thanks to everyone's generosity significantly surpassing the projections based on past years, particularly with the call to support the Fellowship Hall renovation. While funds weren't spent exactly as expected a year ago, overall expenses stayed within budget, with all but break-even results.

- c. <u>Motion</u> to set the Mission and Service Fund Goal for 2024 at \$20,000, including UCW contributions. Moved by Marion Stoneman, seconded by Bill Imeson. **Carried.**
- d. <u>Motion</u> to accept the proposed monthly Local Missions for 2024 (the same as in 2023): Moved by Marion Stoneman, seconded by Jane Moerschfelder. **Carried.**
- e. <u>Motion</u> to accept the Trust Fund Reports: Moved by Keith Crawley, Trustee Treasurer, seconded by Donna Imeson. **Carried**.

 Keith Crawley reported the Dorothy Smith estate was finally settled and funds received. The Wilson/Senn Fund will continue to support the Summer Camp. The Ron Smith window in the Narthex needs to be removed and the lead reinforced and the leaded stained-glass window above the doors on the south side needs to have a storm window applied to the outside for protection.
- f. Motion to accept the UCW Financial Report: Moved by Margaret Crawley, seconded by Grant Howley. Carried.

 Marg Crawley reported that the fund for the Wesley Methodist Cemetery has run out and future expenses would need to be paid through the General Fund. The UCW generated \$15,000 through catering in the past year. Paul Mitrovich added that they were very good meals. Marg also confirmed that the UCW would be donating \$3,600 to the Mission and Service Fund again in 2024.
- 12. <u>Motion</u> to accept the Committee and Group Reports as printed. Moved by Roy Shipton, seconded by Amelia Bentley. **Carried.**
- 13. **Nominating Report**: Audrey Derii was very pleased to announce that members of the congregation had readily stepped up for vacant positions. She thanked Leigh-Anne Unrau (new Chair of Council) Marie Salmon (Christian Development) Sandra Morrison (Membership and Pastoral Care) Robin Gauthier (Chair of Worship & Music). Audrey also thanked Pat Ottaway-Bryan for her two years of service as the Chair of Church Council and also thanked Reese McMillan and Donna Imeson for their great work as the Christian Development Committee.
- 14. <u>Motion</u> that the proposed 2024 State of Officers and Committee Members be accepted as printed in the Annual Report: Moved by Audrey Derii, seconded by Paul Mitrovich. **Carried.**
- 15. New Business
 - a. <u>Motion</u> to accept the Congregational Goal for 2024: **To measurably grow our church family by meaningfully engaging with the community in 2024.** Moved by Robin Gauthier, seconded by Leigh-Anne Unrau. **Carried.**
 - b. A suggestion was made by Bruce MacDonald that there be a committee to make an event of the anniversary of the church (180 years) this year, by inviting former members to attend. After discussion a small committee was suggested consisting of Bruce MacDonald, Paul Mitrovich and Reese McMillan.
 - c. Reese McMillan also suggested that we need to focus on bringing a younger demographic into the church and hopes more will be drawn with the VBS and BBQ after for the families.

There has been extra spending on redecorating the parlour and finishing up the Fellowship Hall renovation which is what has really used up funds this year as opposed to having a shortfall in regular operating costs. Expenses do continue to go up. Please make any changes to PAR amounts in writing, and request new numbered envelopes if you use them. Mission and Service monies are on track. \$300 was collected from the Loonies and Twonies campaign.

Budgeted amounts reflect known 2025 income/expense and adjustments to non-fixed amounts to reflect year-over-year trends while providing for a level of activity similar to 2024, including offering a free 5-day summer camp. Special projects include additional work in the parlour and provision for window coverings, bat assessment, refinishing the Grand Room floor, completing preventative repairs to aging organ components (approved/not finished in 2024) and utilizing the 2025 provincial security grant for churches. Full building insurance cost is included. Significant increases are known/expected for Internet services. A worst-case deficit of -\$20,636.43 results, continuing a normal program of activities with flexibility for emerging issues.

FINANCIAL REPORTS

2024 Certification Report

We have reviewed and performed certain procedures on the accompanying financial statements of the following groups at Grace United Church:

- Operating Funds (including Missions & Outreach)
- Trustees
- United Church Women

The financial statements include the respective balance sheets as at December 31, 2024, the income statements and the statements of fund balances for the year then ended.

Our review of the documentation to support the figures reported included the year-end reconciliation of the bank statements to the balance sheets, payroll statements, and cheque logs. We undertook testing and tracking of a sample of transactions, reviewing allocations for reasonableness, confirming donations were recorded and that payments were made as approved including salaries and benefits. Further we discussed the procedures in place and verified that payments were properly documented and cheques signed by two independent authorized individuals.

In common with many charitable organizations, Grace United Church derives most of its revenue from donations, the completeness of which cannot be fully verified. The congregation should be aware that since the Covid-19 pandemic, there are rarely volunteers to count the weekly offering, much of which has moved online and to monthly giving which greatly reduces the workload. The Treasurer has reported that over 97% of the offering in 2024 was received via cheque or electronic means, the deposit of which can be verified against bank statements if needed. Should donors have concerns, they are encouraged to consider using these verifiable means of giving. The church has always relied on donors to review their bank statements and tax receipts and report any concerns. We can confirm that the records reviewed were consistent with each other and the revenue presented reflects the amounts recorded by the banks and in the records of the church.

Revenue from the 2023-24 Ontario Anti-Hate Security and Prevention grant was utilized in 2024.

Required annual filings have been submitted and the church's charitable registration is active.

Based on the work performed and discussions with the Treasurer we can report that the 2024 financial statements as presented are supported by appropriate documentation. The procedures used by the Treasurer are consistently applied and the information we require as a church can be readily produced.



The Finance Committee consists of George Greenlees, Keith Crawley and Donna Imeson. The majority of the accumulated financial assets under the responsibility of the Trustees continue to be invested with Aligned Capital Partners Inc., and managed locally by Brad Armes. Meetings are held during the year with Mr. Armes to review the investments and to ensure the investments and the asset mix continues to be in line with the Grace Investment Policy.

The Trustees were delighted Grace's Summer Camp could again be supported through the Wilson/Senn Fund and will be again in 2025. As well this year, a grant was offered to four children to attend a Christian program in the community.

The Ron Smith stain glass window in the Narthex was repaired by Trillium Glass. The cost was \$1,017 (incl tax). The storm window for the half-moon window above the front doors was installed.

Rev. Wells took his *Good Grief* sessions on the road this year, running a series in the spring at the Community Support Centre. Another series was held at Grace in the fall, and with the positive feedback, this alternating pattern may continue in future. The *Digging Deeper* sessions also continued most Tuesdays – in the fall convincing him to do a deep dive into the book of Revelations.

Our outreach to families in the community through our annual Summer Camp was once again highly successful thanks to our many church volunteers who supported the vision of our camp coordinators, Donna Imeson and Gillian Street. 21 out of 26 campers from 2023 came back to learn about when Jesus was a Kid in *Hometown Nazareth*. Grant Howley's goats made another appearance, and camp families raised \$233 to send to World Vision to purchase two goats for a needy family. We appreciate the continued support of the congregation providing not only countless hours of time, but also financial funding through the Wilson/Senn Bequest. Summer Camp 2025 will focus on Joseph's Incredible Journey in Egypt, for the first time running a full five days from July 7-11, and we will certainly be most grateful for your support again.

Wesley Methodist Cemetery

Community members continue to offer volunteer hours with the Grace United Church Caledonia Old Methodist Cemetery Restoration Committee. The committee will be completing its three-year community partnership in June 2025 with the County of Haldimand whereby the county partially reimburses the church for their expenses and their recorded volunteer hours.

On June 4th Bill Young, Roman Wasylyk and Kathryn Kennedy, a Find a Grave volunteer as well, completed 12 hours cleaning headstones and finding places for headstone pieces with "re-claimed" headstone "puzzles".

On September 10, Bill Young, Harland Young, Kathryn Kennedy, Dan Young and Marie Salmon volunteered for 31 hours. The remaining headstones were cleaned at the cemetery. The headstones of Ellen Patterson and Elizabeth Ferris were brought to the surface and cleaned. The 18 headstone bases were catalogued so that they can be part of a conversation with the County of Haldimand, the Cemetery Committee, and a professional cemetery restorer about what to do with them to use and/or remove them from the cemetery.

Throughout 2024, Kathryn Kennedy has donated many extra hours taking current photos of the cleaned headstones at the cemetery and posting these new photos on the Find a Grave site. Many memorials have had extra information added by Kathryn which has promoted the restoration efforts at the cemetery.

Marie Salmon is a 20-year COMC restoration committee member. Marie continues to be the record keeper for the Church-County partnership.

County of Haldimand staff, Sheryl Sawyer and Liam Morin, have been informed about the 2024 progress at the cemetery by the Restoration Committee and current and future needs of the cemetery.

Moving forward the group still has goals to:

- work with the County of Haldimand to remove the headstone bases that are not being used, as well as the marble slabs and old cement curbs currently stored at the front of the cemetery near the old fence line to enhance the look of the cemetery;
- work with the County of Haldimand to replace the fence placed along the eastern property line;
- continue to encourage the County of Haldimand to ensure grass maintenance up to the eastern property line;
- continue to promote the actions of the committee with COMC neighbours Mary Jo Albanese-Glauser and Jim Hutton;
- continue research to find living descendants to be aware of and contribute to the future restoration of the cemetery by building on the success of the BOGLE family monument restoration;
- to continue to develop a new transcription of the cemetery identifying the current headstones and their location;
- to continue to find local community groups and/or members who will continue the restoration
 of the cemetery and to make this restoration a County of Haldimand priority especially since
 the Grace United Church Restoration Committee may soon be dissolved.
