Service call from MCS Net:

- The landfill is heavily surrounded by trees, significantly limiting line-of-sight to the available MCS Net network.
- They strongly recommend the installation of a personal tower at the site.
 Elevating the radio equipment above the treeline would significantly improve signal quality, ensure consistent service.
- Recommend a tower between 35 and 45 feet in height.

Get in contact with MCS Net for a quote for a personal tower and to let them know that if they are interested in installing a larger tower in our area that we have land available.
