You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy an items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Payment Policy

Payment in full is expected at time of arrangement. For your convenience, we accept cash, personal check, Visa, and MasterCard. If paying by credit card, a 4% processing fee will be applied. If you anticipate any difficulty in meeting this obligation, please feel free to discuss it with us.

Basic Services of Funeral Director and Staff **\$2,620.00**

Includes 24 hour availability of staff; initial receiving, handling, and sheltering of remains; the arrangement conference; obtaining obituary information; funeral or memorial service planning; consulting or coordinating arrangements with family, clergy, cemetery, crematory, florists, and other third parties; obtaining and filing necessary authorizations and permits; and a share of our overhead expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Embalming **\$690.00**

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Funeral Service with Limited Viewing Followed by Interment (all in one day) \$4,895.00

Includes basic services of funeral director and staff; transfer of remains to funeral home, embalming, cosmetology, dressing, and casketing of remains; two hours of viewing immediately prior to services; use of facilities and staff for funeral ceremony, use of equipment and staff for graveside service; hearse.

Graveside Service Preceded by Limited Viewing \$4,395.00

Includes basic services of funeral director and staff; transfer of remains to funeral home, embalming, cosmetology, dressing and casketing of remains; one hour of viewing immediately prior to services; use of equipment and staff for graveside service; hearse.

Direct Cremation (no viewing or services) **From \$2,790.00 to \$2,840.00**
Includes basic services of funeral director and staff; transfer of remains to funeral home; transfer vehicle. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard.
