Angela Howell reported updates on the ST RT 49 Waterline Project/Quik Trip Development Agreement. On a recent conference call with Montgomery County TID and Clayton, there was mention of rising concerns and perceptions that prevailing wage may be used during this project due to the fact that there is a mix of private and public funds. The current draft agreement calls for competitive bidding which gives us a fixed price, but prevailing wage would not and the cost would be much more expensive than what has already been discussed. We are being asked to consider other options because of the mixed funds issue. Angela stated that she has sent the information to our council at Montgomery County and will provide updates at the next meeting.

Ernest Laycox - Complaint on EZ Trucking on Brookville-Salem Road. Mr. Laycox states this area is not zoned to have multiple terminals and oil can't be stored on the grounds where leaking can occur. All of his neighbors run off of a well. Mr. Laycox has dealt with an unbearable amount of dust, knows of an alleged felony due to a stabbing recently, sees many trucks going in and out 24/7. Mr. Laycox's biggest concerns for his health are with the water that he drinks and air quality, potential accidents & traffic issues along with his safety and well-being. Chief Birk and Greg assured Ernie these issues are being looked into.

Dan Ennist - Complaint on EZ Trucking. This area/land was originally zoned as a variance for the repair of semi tractors only. The owners specifically pointed out during a previous meeting from many years ago where it was promised that no sales, only repairs. Mr. Ennist believes it should be considered a Truck Depot and they now have a truck wash, repairs and sales of trucks. Greg and Chief Birk are currently diligently working on this project.

Joe Steinbrunner - His main complaint is also for EZ Trucking. Mr. Steinbrunner's main concerns are traffic and water safety.

Greg Steinbrunner - Agrees with his son (Joe Steinbrunner), he has the same complaints and concerns.
