By signing this agreement, I agree that no alcohol of any kind will be provided by the driver of Go Transportation. I also agree that passengers under 21 years of age will not consume alcohol of any kind while on board the bus. I agree that we will not hold the driver or the owner responsible for any accidents or injuries incurred through the improper use of the structural support poles. We enter and ride this bus at our own risk, and will not hold the driver of Go Transportation responsible for our own action while on the bus.

TERMS AND CONDITIONS

Renter Eligibility:

Renter must be 18 years of age or older. Valid identification must be provided prior to boarding the bus.

Renter Responsibility:

The renter is responsible for all activities of the passengers on board the bus. This includes making sure all passengers who consume alcohol while on the bus are 21 years of age or older. Go Transportation cannot be held liable for items left on the bus. Go Transportation shall not be responsible for any items left in the vehicle or the safe keeping of any item(s). Please inspect the vehicle prior to dismissal.

Bus Deposit:

A \$200 deposit is required to secure your bus reservation. A deposit check or credit card payment must be received within seven days of making your reservation or the reservation will be considered cancelled. All deposit checks will be cashed upon receipt. Any deposit made less than two weeks prior to the event date must be made and all or a portion of your deposit will be forfeited. Any damage assessment will be determined once the bus has returned to the shop and has been thoroughly cleaned. Deposit refunds will be made via company check or credit card refund based on original payment and will be mailed within 10 days following your event date.

Payment:

Full payment must be made in cash only prior to boarding the bus. Payment can be made by check or credit card, but must be received at least 7 days prior to your event date.

Cancellation Policy:

If you choose to cancel your reservation, you must do so at least 2 weeks prior to your event date. Failure to do so will result in forfeiture of your deposit.

Alcohol Policy:

Alcoholic and non-alcoholic beverages are permitted. Beverages can be brought on board in solid coolers (no soft side, Styrofoam, or damaged coolers will be permitted). Anyone consuming alcohol while on board the bus must be 21 years of age or older.

Smoking Policy:

There is absolutely no smoking on the bus. No exceptions.

Rules of Conduct:

Go Transportation reserves the right to immediately terminate the job, for all parties in attendance for the use of illegal substances and/or any illegal activity by any guest in attendance. There will be no refund of any monies to the client, due to the negligent behavior of the passengers,

Arrival Time:

The time of arrival at the starting point, destination or return to point of origin cannot be guaranteed. Travel routes will be established by Service Provider and requests for specific routes by the Rental Party will be at the Service Providers discretion. Travel speed all times at speeds compatible with safe operation. Road, traffic and weather and no refunds shall be given as a result of late arrivals due to such conditions or other occurrences out of the control of Go Transportation or Service Provider.

Renter agrees that the Go Transportation shall not be held liable for any damages arising out inability to perform due to inclement weather, mechanical or electrical difficulties, delays due to any type of traffic conditions, or an unforeseen events beyond the reasonable control of the bus service during normal driving conditions.

Your signature below demonstrates full understanding and agreement with the policies as set forth above. At any time these conditions are agreed upon and signed, the contract for hire will begin.
