When asked to identify some of the challenges faced in achieving this honor, Dr. Silvia Operti-Considine, owner of Kidz 1st, stated the most difficult aspect of obtaining the NCQA status was articulating on paper the various protocols and procedures followed on a day-to-day basis that meet the NCQA requirements. In discussing the various efforts that were undertaken to achieve the designation, Dr. Operti-Considine also related that the staff's time, determination and collaboration put forth with the United Physicians care team is something for which they hold a tremendous amount of pride.

Follow-up is another aspect of operations that Dr. Operti-Considine holds in high regard. "When a patient is sent to a specialist, whether it involves laboratory or radiology testing for example, we have developed procedures that allow us to prioritize how important those orders are and follow-up accordingly. Our entire staff works in unison to help patients get the care they need and have results communicated in a timely manner. Additionally, we call patients seen at the urgent care, ER or hospital to determine their status, discuss symptoms and decide together if they need to come into the office for further evaluation/treatment," said Dr. Operti-Considine.

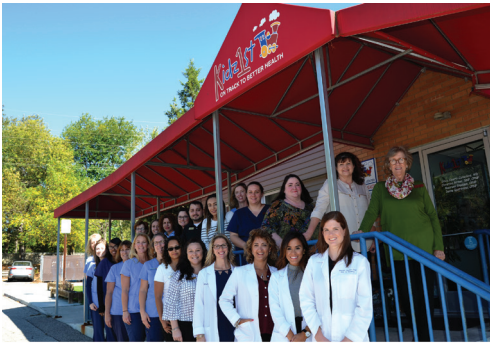


Dr. Operti-Considine communicates with other providers using direct messaging within the EHR.
