BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF .....	\$2,295.00
Basic services, not to be included in the prices of other categories that are furnished by a funeral provider in arranging any funeral, such as conducting the arrangements conference, planning the funeral, obtaining the necessary permits and placing obituary notices. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.)	

## EMBALMING

EMBALMING .....	\$550.00
Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as a direct cremation or immediate burial.

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME.....	\$2,625.00
This charge includes basic services of the funeral director and staff, care of the deceased, and transportation of the deceased to the cemetery without scheduled ceremony.	

## DIRECT CREMATION

DIRECT CREMATION AVAILABLE.....	FROM \$1,995.00 TO \$2,090.00
This charge includes transfer of the remains to mortuary, basic services of the funeral director and staff, and cremation.	
DIRECT CREMATION WITH CONTAINER PROVIDED BY PURCHASER .....	\$1,995.00
DIRECT CREMATION WITH ALTERNATIVE CONTAINER.....	\$2,090.00
If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). Handling and processing fee may apply if weight exceeds 300lbs.	

## NATURAL ORGANIC REDUCTION

Natural Organic Reduction, also known as terramation, utilizes the body's own naturally occurring microbes to gently transform remains into nutrient-rich soil. The process is conducted in individual vessels and takes 60-90 days to complete. The resulting soil can then be returned home to be placed in gardens, house plants, or donated to a woodland property in Kent, WA to aid in the restoration and rejuvenation of the forest.

### ABOUT RETURN HOME

Return Home transforms human remains into rich, fertile soil through a service called Terramation. They help gently return our deceased to the earth so that new life may be created, just as nature intended.

## PAYMENT POLICY

In order to serve all clients fairly and to prevent misunderstandings, McCormick & Son Mortuaries have established a uniform payment policy.

It is customary to pay charges at the conclusion of the arrangement conference with your director.

Payment of charges is required by the morning of the day prior to the first viewing or service. Acceptable forms of payment are: check, cash, MasterCard, Visa, or Discover, AmEx, funeral trust accounts and life insurance policies. There is a 3% merchant services processing fee when paying by Credit or Debit Card. We do accept cash or check in person.

Life insurance\* policies may be accepted under the following conditions:

1. The policy is in force and assignable
2. The policy is an individual policy and not a group policy
3. That no loans have been taken out on the policy
4. The original policy is surrendered
5. That the beneficiary or beneficiaries all sign all necessary documents
6. The insurance company provides the mortuary with written assurance that they will pay the funeral home
7. The insurance company conveys assurance that there are enough funds in the insurance to pay for the contracted arrangements
8. That all of the above be accomplished three (3) working days prior to the morning before the first event: viewing, service or scheduling a cremation
9. Payment of all cash advance items are to be paid by the morning of the day prior to the first viewing or service.

Third party checks, future payments from estate funds and credit cards in the name of the decedent will not be accepted.

Should a credit balance result from adjustments to the contract a refund will be issued after the 15th of the month following the month in which services were held to allow time for processing of any billing adjustments received from outside service providers.

### **Payment due in full 24 hours prior to service.**

\*There will be a \$250.00 processing fee per policy for insurance policy assignments (this does not apply to McCormick & Son Mortuaries funeral insurance plans). Policies under two years old are generally contestable and may not be accepted.
